Procedural Background

This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder. The issue on appeal was MassHealth's March 6, 2023 denial of the Appellant's January 13, 2023 long-term care application because MassHealth determined that the Appellant has more countable assets than MassHealth benefits allow. (130 CMR 520.003; 520.004; Exhibit 1). The Appellant timely appealed on April 28, 2023. (130 CMR 610.015(B); Exhibit 2)

Following the hearing, the record was left open until July 31, 2023 for the Appellant to submit documentation showing that the facility filed a petition for conservatorship. The record was also left open until August 21, 2023 for MassHealth to review the submitted documentation. (Exhibit 6). Additional information was provided to MassHealth. (Exhibit 7). MassHealth subsequently received the necessary documentation and responded on July 5, 2023 that the Appellant was approved as of November 1, 2022. The Appellant's assets were made inaccessible for six (6) months pending conservatorship appointment. (Exhibit 8).

As no issue on the appeal of the March 6, 2023 notice for over assets pursuant to 130 CMR 520.003 and 130 CMR 520.004 remains in dispute, this matter is dismissed pursuant to 130 CMR 610.051(B). Any subsequent denial notices issued by MassHealth may be separately appealed.
