Procedural Background

This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder. The issue on appeal was MassHealth's January 17, 2023, denial of the Appellant's application for MassHealth due to the Appellant not providing information required to decide the Appellant's eligibility within the required timeframe. (Exhibit 1; 130 CMR 515.008) The Appellant timely appealed on May 16, 2023. (Exhibit 2; 130 CMR 610.015(B).)

At the June 15 2023 hearing, the record was left open until June 30, 2023, for the Appellant to submit necessary verifications, and until July 14, 2023, for MassHealth to review the proffered information to determine the Appellant's eligibility. (Exhibit 8) On June 29, 2023, the Appellant requested additional time due to difficulty in receiving requested banking information. (Exhibit 9) The request for additional time was granted, the record was left open until July 21, 2023, for the Appellant to submit necessary verifications, and until August 4, 2023, for MassHealth to review the proffered information to determine the Appellant's eligibility. (Exhibit 10). On July 12, the Appellant requested a subpoena to obtain the necessary baking information. (Exhibit 10). A subpoena issued. (Exhibit 12) On July 31, 2023, MassHealth responded that review of provided documentation resulted in an approval for the Appellant's MassHealth coverage, effective the date requested by the Appellant. (Exhibit 13).
