## **Procedural Background & Outcome**

This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder. The issue on appeal was MassHealth's June 14, 2023 denial of the appellant's prior authorization request for comprehensive orthodontia. (Exhibit 1.) The appellant timely appealed on July 5, 2023. (Exhibit 1; 130 CMR 610.015(B).)

At the hearing, the appellant's representatives requested that the record be left open to submit a medical necessity narrative. The narrative was submitted and MassHealth's representative overturned the denial, agreeing that the appellant qualified for comprehensive orthodontia. (Exhibits 4-5.) As MassHealth and the appellant have resolved all issues on appeal, this matter is DISMISSED pursuant to 130 CMR 610.051(B).<sup>1</sup>

<sup>&</sup>lt;sup>1</sup> The appellant's parents had also received a notice stating that the provider was not covered by MassHealth. DentaQuest has verbally informed the appellant's parents that this notice was erroneous, and the provider still appears in the published MassHealth provider list. However, provider enrollment is not an appealable issue at a Fair Hearing. (See 130 CMR 610.032; cf. 130 CMR 450.201; 450.212; 450.241.)
