## APPEAL DECISION

This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder. On July 21, 2023, MassHealth denied Appellant's 2/10/23 application for long-term care benefits due to her failure to submit verifications by the required deadline. See Exhibit 1, pp. 4-6. On August 21, 2023, Appellant, through her power of attorney, filed a timely request for a fair hearing. See id. at 2. A hearing was scheduled for October 5, 2023.<sup>1</sup> See Exh. 3. At hearing, the MassHealth representative testified that one verification remained outstanding. The record was left open for Appellant to submit the additional verification. See Exh. 6. During the record open period, MassHealth confirmed it received the final outstanding verification and would proceed to determine Appellant's eligibility honoring Appellant's 2/10/23 application date. See Exh. 7-8.

As all issues pertaining to the 7/21/23 MassHealth notice have been resolved, this appeal is DISMISSED. See 130 CMR 610.051(B).
