This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder. The issue on appeal involves CCA's modification of Appellant's prior authorization request for Personal Care Attendant (PCA) services and denial of Level I appeal. Exhibit 1. At hearing, the parties agreed that CCA's restoration of requested 43 day/evening PCA hours and 14 night PCA hours, effective October 20, 2023, resolved the issue in dispute. CCA testified that it would schedule a new assessment and a new determination would be made with appeal rights.

As there was an adjustment that resolves the issue in dispute between the parties, this appeal is dismissed. 130 CMR 610.035(A)(8), 130 CMR 610.051(B), 130 CMR 610.083(C).
