## APPEAL DECISION

This hearing was scheduled pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder. The issue on appeal involved the October 2, 2023 denial of the frail elder waiver because MassHealth had not received all verifications. Exhibit 1. Appellant filed this appeal on October 24, 2023. Exhibit 2.

On the day of hearing, MassHealth representative approved Appellant for the frail elder waiver, which provides Appellant with MassHealth Standard coverage and payment of Appellant's Medicare Part A/B premium effective October 1, 2023. As the issue in dispute has been resolved, this appeal is dismissed. 130 CMR 610.035(A)(8), 130 CMR 610.051(B), 130 CMR 610.083(C).

### Notification of Your Right to Appeal to Court
