This hearing was conducted pursuant to Massachusetts General Laws Chapter 118E, Chapter 30A, and the rules and regulations promulgated thereunder.

Jurisdiction

Through a notice dated January 11, 2024, MassHealth notified the Appellant that it had approved her for MassHealth Long-Term-Care Services in a Nursing Facility effective November 14, 2023. MassHealth determined that the Appellant was ineligible between May 16, 2023, to November 13, 2023, because of a transfer of assets. 130 CMR 520.518, 130 CMR 520.519, and Exhibit 1. The Appellant filed a timely fair hearing request to "preserve [the] original start date" on January 19, 2024. 130 CMR 610.015(B) and Exhibit 2.

The hearing was conducted telephonically, and the Appellant's representative verified the Appellant's identity. The MassHealth representative testified that the Appellant is over the age of 65, has a household size of two, and a spouse who lives in the community. The MassHealth representative testified that payment had been requested, dating back to May 16, 2023, but that there was an ineligibility period due to a transfer of assets. The MassHealth representative testified that MassHealth had received some verifications on January 29, 2024, which resulted in MassHealth determining an earlier eligibility date of October 8, 2023.

The record was held open until February 26, 2024 for the Appellant's representative to submit evidence regarding the transfer of assets. The record was held open until March 4, 2024, for

MassHealth to review and respond. On February 29, 2024, the MassHealth representative responded and stated that she had received the documentation needed, and that the new eligibility date is May 21, 2023. Exhibit 7. The MassHealth representative stated that, "[t]here is a penalty time period between 5/16/23 to 5/20/23 due to transfer of assets of \$2000 reported given as a gift. The approval letter has been generated and will go out in the mail soon." *Id.*

Because MassHealth reviewed the submitted evidence and adjusted the eligibility start date, there are no longer any issues in dispute before the Board of Hearings. Therefore, this appeal is dismissed. 130 CMR 610.035(A)(8).¹
