Instructions

To fill out this application, select the service type needed and move through sections filling out each field. E-mail completed application to the address above.

- If vehicle is owned by a third person (includes leasing company), attach a signed and dated written statement from that third person or leasing company acknowledging that a Blue Light may be mounted and displayed on the vehicle, and that such Blue Light may only be used by the Permit holder and only for official use. A lease will not be recognized unless the Lessor is registered as such with the MA Department of Revenue. NOTE: A Blue Light Permit cannot be issued for a vehicle to be operated by a police officer unless the officer is also the "owner" of the vehicle (per Chapter 90, Sec. 7E).
- Additional Permit: A Blue Light Permit holder may apply for an additional Permit for a vehicle owned, leased, or regularly used (must be more than incidental or occasional use) by the Permit holder. However, a police officer of any city, town, or state agency applying for an additional Permit must own the vehicle for which the additional Permit is sought.
- Once issued, a Blue Light may only be displayed when the Permit holder is operating the vehicle in the performance of official duties. The Permit must be carried by the operator or in the vehicle. A Permit does not authorize the operator to violate motor vehicle laws.

M.G.L. Chapter 90, Sec. 7E requires the "Head of the Police Department" to complete this Application

M.G.L. Chapter 90, Section 7E authorizes motor vehicles and trailers (1) used solely for official business by any police department of the Commonwealth or its political subdivisions; (2) or by any railroad police department; or (3) by any college or university police department whose officers are appointed as special state police officers by the colonel of state police pursuant to Chapter 22C, Section 63 (and subject to such special rules and regulations applicable to such college or university police department as the Registrar may prescribe) to mount and display a flashing, rotating or oscillating Blue Light without a Permit from the Registrar. Section 7E authorizes certain other vehicles operated by law enforcement officers or enforcement-related personnel to mount and display a flashing, rotating or oscillating Blue Light if the Registrar has issued a Permit. This Application form is only for users requiring a Permit.

ONLY ORIGINAL Application Forms will be ACCEPTED. No copies or faxes.

Note: Any Permit issued will expire on the same date the vehicle registration expires.
