Instructions

Mail the completed application to the address at the top of the form or bring to any full service RMV location. A photo of the vehicle showing the business markings and lettering is required to be submitted with this application.

Visit Mass.Gov/RMV for a list of RMV Service Centers.

Follow the procedures below. The numbers of these procedures correspond to the numbered items on the Application For Compliance Decals.

- A. **A1.** Enter your last, first, and middle name as it appears on your driver's license
A2. Enter your driver's license number or the words "no license"
A3. Enter the corporate or business name as it appears on your Section Five Registration.
A4. Enter the Employer Identification Number (EIN) or Federal Identification Number (FID) as it appears on any IRS document you have.
A5. Enter the address of the business as it appears on your Section Five Registration.
A6-A7. Provide phone number and email address.

- B. **B1.** Select the appropriate Section Five Registration type.
B2. Enter the registration number.

- C. **C1.** Enter the following vehicle information for each vehicle. (For vehicles that are titled, use the information that appears on the title.)
VIN: Enter the 17-character vehicle identification number for automobiles and trucks.
Title Number: Enter up to eight digits for the title number as issued by the Massachusetts Registry of Motor Vehicles, if applicable.
Year: Enter the year of manufacture (for example, 2021, 2025)
Make: Enter the make code (for example, chev, ford). This is a maximum of four characters.
Model: Enter the model name or number. This is a maximum of five characters.
Body Style: Enter the body style name. Select the appropriate style from the list below and write the name in the field.
Horsepower: Enter the horsepower.
Gross Vehicle Weight: Enter the weight in whole pounds.
