V. References.

Please provide three (3) written, original recommendations. At least two of the three written recommendations must address your professional experience and qualifications. At least one of the letters must reflect -- based on personal knowledge -- your reputation for good character, honesty, and integrity. Those making the recommendations should include contact information, and none may be family members or relatives.

You may also provide a list of five (5) additional names as references the appointing authority may contact.

Please note that prior to appointment to the commission, a background investigation shall be conducted into the financial stability, integrity and responsibility of a candidate, including the candidate's reputation for good character, honesty, and integrity. In order to advance through the appointment process, you must agree to a background check. M.G.L. c. 23K, § 3.

Further, each candidate for employment as a state employee is required by the appointing authority as part of the application process to disclose, in writing, the names of any state employee who is related to the candidate as spouse, parent, child or sibling or as the spouse of your parent, child or sibling. In order to advance through the appointment process, you must agree to make such a disclosure. G.L. c. 268A, § 6B.

³ For purposes of this Application, "immediate family member" means the applicant and his or her spouse/ domestic partner, and their parents, children, brothers, and sisters.
