- ☐ Documentation of work experience

Additional Prerequisites:

Assistant Nuclear Plant Operator

- ☐ Must provide documentation that you have been employed in a steam power plant as a fireman, water tender, control room assistant, or as a designated assistant to the engineer in charge of an eight hour working day shift for not less than one year.

Nuclear Power Plant Operator

- ☐ **Must be a citizen.**
 - ☐ Must provide documentation that you have been employed in a steam power plant or a nuclear steam power plant and have and used a Massachusetts second class engineer's license or an assistant nuclear steam power plant operator's license for not less than one and one-half years.
- OR
- ☐ A person who has a bachelor of science degree in engineering from any duly recognized school of engineering, who has been employed for one year in connection with operation of a steam plant.

Nuclear Power Plant Senior Supervising Engineer

- ☐ **Must be a citizen.**
- ☐ A person that has attended a recognized full time school of nuclear power plant engineering for one year or more shall be permitted to substitute the time in school for an equivalent year of experience as a nuclear power plant operating engineer, however, that the time in school shall be allowed as credit for experience for the license examination immediately following the time spent in school.
