Cranberry Bog Acquisition for Restoration Program

COMMBUYS BID Number: BD-24-1042-ENV-ENV01-100438

I. GRANT OPPORTUNITY SUMMARY:

A. Proposals Sought For: Financial assistance to qualified 501(c)(3) organizations, municipalities, and other qualified conservation organizations for the acquisition of retired or soon to be retired cranberry bogs and associated uplands for the purpose of subsequent ecological restoration to natural functioning wetland habitat and provision of broader ecosystem services.

B. OVERVIEW AND GOALS: The Executive Office of Energy and Environmental Affairs (EEA) protects, conserves, and restores the natural resources of the Commonwealth. To fulfill this mission, Rebecca Tepper, Secretary of EEA, makes available funding for the Cranberry Bog Acquisition for Restoration Grant Program. This program provides funding to assist qualified 501(c)(3) organizations, municipalities, and other qualified conservation organizations in acquiring interests in land containing retired or soon to be retired cranberry bogs and associated uplands for the purpose of subsequent ecological restoration to natural wetland habitat and provision of broader ecosystem services.

The Cranberry Bog Acquisition for Restoration Program is a component of the Healey-Driscoll Administration's goal of conserving natural resources and open space and addressing climate change. This BID is part of the Administration's efforts to permanently preserve the Commonwealth's rich natural heritage for generations to come. The Cranberry Bog Acquisition for Restoration Grant Program also supports state government efforts to adapt to climate change and build a more resilient Commonwealth, by including resiliency criteria in its rating system. It is a <u>reimbursement</u> program.

C. ELIGIBLE PROJECTS:

- 1) Land or a Conservation Restriction (CR) purchase by an eligible Applicant
- 2) Due diligence costs for donations of land or CRs to an eligible Applicant

See further detail on eligible projects in Section 2B.

- **D. ELIGIBLE APPLICANTS:** This BID is open to qualified 501(c)(3) organizations that have been formed for one of the purposes described in Section 4 of Chapter 180 of the General Laws, municipalities, and other conservation organizations. If applicable, an organization must have 501(c)(3) status at the time an application is submitted. See further detail on eligible applicants in Section 2A.
- **E. APPLICATION DEADLINE: Thursday, June 13, 2024, at 5:00 pm**. See further detail on deadlines and grant program calendar in Section 4.
- **F. FUNDING AVAILABILITY:** The maximum grant award for the purchase of land or a CR is \$2,000,000. The maximum award for due diligence costs related to a gift of land or CR is \$20,000. The maximum reimbursement amount is 90% of the total eligible project cost up to the applicable grant award maximum. Exceptions may be

made at the Secretary's discretion. There is no guarantee that monies will be awarded. See further detail on funding availability in Section 2E.

- **G. Non-state Funding Requirement:** This is a reimbursement program. Additionally, applicants selected to receive funding must demonstrate the use of funds from non-state sources comprising at least 10% of total project costs. Approved expenditures must not be made until after the selected applicant has an executed contract with the Commonwealth. See further detail on budget requirements in Section 2F.
- **H. TOTAL ANTICIPATED DURATION OF CONTRACT(s):** Contracts issued pursuant to this BID must expend all eligible project costs on or before June 30, 2026, to be eligible for reimbursement. See further detail on anticipated duration of contract(s) in Section 2H.
- I. REGULATIONS, STATUTES, OR AUTHORIZATION GOVERNING THIS GRANT PROGRAM: Subject to 815 CMR 2.00 and Chapter 102, Section 2A of the Acts of 2021, this grant program provides funding to assist qualified 501(c)(3) organizations, municipalities, and other qualified conservation organizations in acquiring property interests for conservation purposes.

Successful applicants may receive funds provided to Massachusetts under the American Rescue Plan Act of 2022 ("ARPA"). As such, these awardees may be considered sub-recipients of ARPA funds and will need to comply with all governing federal laws and regulations. These include, but are not limited to: 2 CFR Part 200 UNIFORM ADMINISTRATIVE REQUIREMENTS, COST PRINCIPLES, AND AUDIT REQUIREMENTS FOR FEDERAL AWARDS (Uniform Guidance); 2 CFR Part 25 UNIVERSAL IDENTIFIER AND SYSTEM FOR AWARD MANAGEMENT; various reporting requirements; and various federal non-discrimination laws including Title VI of the Civil Rights Act of 1964, Section 504 of the Rehabilitation Act of 1973, and the Age Discrimination Act of 1975. Grant contracts will include language reaffirming these requirements and providing the Commonwealth with remedies if a grant recipient fails to comply with these requirements. All grant awardees will be notified of the source of funds for their grant award.

2. PERFORMANCE AND CONTRACT SPECIFICATIONS

A. ELIGIBLE APPLICANTS:

This BID is open to qualified 501(c)(3) organizations, municipalities, and other organizations qualified to hold conservation land. Multiple contracts may be awarded to the same applicant under this BID. Applicants may choose to package several adjacent landholdings into one application. Unrelated, separate landholdings must be submitted as individual applications.

B. ELIGIBLE PROJECT(S)/SCOPE(S) OF WORK:

EEA seeks to further the conservation of retired or soon to be retired cranberry bogs and associated uplands so that the natural habitat values and climate resilience benefits of intact wetlands habitats are realized. Eligible projects include:

1.) Purchase of land or a CR

An eligible Applicant may request grant funding for reimbursement of acquisition and due diligence costs associated with the purchase of land (fee simple) or a perpetual CR as defined in G.L. c. 184, § 31 that

provides for conservation and restoration of the land in question, and appropriate passive uses of the property. Conversion of a term-limited CR to a permanent CR is eligible for funding. Eligibility for funding is limited to costs associated with the purchase of land or interests in land for perpetual conservation.

2.) Due diligence costs for gifts of land or a CR to an eligible Applicant
An eligible Applicant may request grant funding for reimbursement of eligible due diligence costs associated with a land or CR gift that provides for appropriate conservation and restoration of retired or soon to be retired cranberry bogs.

Land that is already permanently protected through Article 97 (e.g., was purchased with EEA grant funding or municipal funding for open space protection), is already held in fee by a land trust, or is protected under a CR, Watershed Preservation Restriction (WPR), or Agricultural Preservation Restriction (APR) is <u>not</u> eligible for funding.

Lands enrolled in Chapter 61, 61A, or 61B are not classified as permanently protected land and are eligible to receive funding. Unprotected state or municipal land is also eligible.

Land designated as development area priorities as described in the South Coast Rail Corridor Plan, Merrimack Valley Land Use Priority Plan, or the I-495/MetroWest Development Compact Plan, or other regional plans will not be eligible for funding. See Executive Order No. 525.

C. APPRAISAL REQUIREMENTS:

Applications must include the appropriate type of valuation or appraisal with the application (applications lacking the appropriate type of appraisal will be rejected). Valuations must be dated no earlier than one year prior to the application submission deadline.

- A. Parcels with an estimated total project cost equal to or greater than \$350,000:

 One full narrative appraisal by a real estate appraiser certified or licensed pursuant to M.G.L. c. 112.
- B. Parcels with an estimated total project cost less than \$350,000:

 One narrative appraisal by a real estate appraiser licensed pursuant to M.G.L. c. 112 OR one contracted market analysis by an appropriate party licensed pursuant to M.G.L. c. 112 OR one contracted opinion of value, completed by an appropriate party licensed pursuant to M.G.L. c. 112.

NOTE: The Applicant or one of the Applicant's project partners must be the client for the appraisal, market analysis, or opinion of value. The owner of the property cannot be the client and cannot donate money to cover the cost.

Applications for projects that involve a land or Conservation Restriction donation to the Applicant **DO NOT require an appraisal**, market analysis, or opinion of value.

D. EVALUATION CRITERIA:

Each application will be scored using the criteria below. See Attachment B for complete project selection criteria.

I. Organizational Characteristics (16%)

Applicants with Articles of Incorporation or other foundational documents that reflect land conservation and habitat protection as a mission, with demonstrated capacity to successfully complete a purchase or gift of conservation land, and with experience successfully stewarding fee or CR interests.

2. Land Protection (12%)

Projects that protect larger areas, promote landscape connectivity by abutting existing protected open space, and/or advance local or regional conservation goals, including greenways.

3. Biodiversity and Natural Resource Protection (16%)

Projects within or adjacent to designated Natural Heritage and Endangered Species Program BioMap Core Habitat or Critical Natural Landscape, that are ranked highly for climate change resiliency based on its TNC map score, and the resource value of which would be more significantly impacted by potential development.

4. Restoration Potential (25%)

Projects that provide excellent ecological restoration potential, due to proximity to other sensitive resource areas, hydrology, connection to other wetlands and/or natural systems, remnant wetland soils, and other factors will be scored highly.

5. Recreational Opportunities (7%)

Project that will provide appropriate passive public recreational opportunities, including to people with disabilities; will serve an under-served area for outdoor recreation based on the amount of protected open space per capita; and will advance goals, objectives, or action plan items stated in the community's *current* Open Space and Recreation Plan (OSRP) and/or Statewide Comprehensive Outdoor Recreation Plan (SCORP).

6. Overall Project Quality and Importance (24%)

Overall quality and importance of the proposed project considering the combination of criteria described above, as well as whether the project is within an Environmental Justice population.

E. FUNDING AVAILABILITY, BUDGETING GUIDELINES & ALLOWABLE EXPENDITURES:

Reimbursement rate: 90% of the total eligible project cost

Maximum award amount: \$2,000,000 for purchase of conservation land or CR

\$20,000 for due diligence costs for a gift of land or CR

Applicants must submit the appropriate type of appraisal, the estimated total eligible project cost, and the specific grant request as part of the application package.

The Cranberry Bog Acquisition for Restoration Grant Program is a **reimbursement** program. Expenses incurred prior to the execution of a contract with the Commonwealth are not eligible for reimbursement. All approved project costs must be expended by the applicant on or before June 30, 2026, to be eligible for reimbursement. Project costs are subject to approval by EEA. Only eligible acquisition and due diligence costs approved by EEA and expended by the Applicant directly will be eligible for reimbursement. Applicants must provide documentation of Applicant's payment when filing for reimbursement for each approved project cost. For acquisitions, reimbursement will be calculated using the lesser of the final purchase price OR the appraised value.

Eligible expense categories:

- Title search
- Acquisition (appraised value or negotiated price, whichever is less)
- Baseline Documentation Report
- Chapter 21E assessment
- Survey
- Legal fees associated with the acquisition
- Recording fees

Ineligible expense categories: Please note that this is not a complete list.

- Application preparation or submission costs in response to BID
- Staff salaries
- Trail construction
- Signage
- Stewardship or monitoring endowments
- Equipment or goods

All contracts shall be subject to available funding, whether through the appropriation and authorization of sufficient funds or the receipt of sufficient revenues. If available funding ceases for any reason, a contract shall be deemed under suspension and contract performance must halt. A contractor will not be entitled to compensation for any performance provided during the period of contract suspension. EEA may lift the suspension if available funding is received. In the absence of foreseeable available funding, EEA may terminate the contract.

F. BUDGET REQUIREMENT:

Applicants must have sufficient funding to acquire the land interests in question, and seek reimbursement upon closing, potentially as each property interest is acquired. The grant award will not exceed \$2,000,000 for the purchase of land or CR and \$20,000 for due diligence costs incurred with the gift of land or CR. Eligible funding sources include, but are not limited to, grants from private or qualified foundations and cash contributions from local partners or individuals. Funds from other state sources may not be used to meet the match requirements of this grant program. The final reimbursement amount will be determined by the total amount spent, as documented through canceled Applicant checks or other proof of payment.

G. PROJECT TERMS:

Awarded projects will be required to abide by the Standard Commonwealth of Massachusetts Terms and Conditions. All final contracts are subject to successful negotiation of a Final Scope of Services. EEA does not guarantee that any contracts may result from this BID, or that any particular funding amount will be awarded. Awarded contracts will be reviewed during their course and, upon request by the Contractor, may be extended or otherwise amended at the sole discretion of EEA. Any extension granted will not necessarily change the monetary value of the contract.

H. ANTICIPATED DURATION OF CONTRACTS:

All contracts will end on June 30, 2026. To be eligible for reimbursement, land purchase and other reimbursable expenditures must be incurred on or before this date. Extension of the contract is at the sole discretion of EEA and is unlikely to occur.

I. DELIVERABLES AND OWNERSHIP:

Property interests acquired with grant funds must be permanently conserved for natural resource protection purposes in a manner that allows for restoration of natural wetland function. This could be accomplished by bringing the property interest under Art. 97 of the Amendments to the Constitution of the Commonwealth, or the recording of a conservation restriction pursuant to Sections 31-33 of Chapter 184 of the MA General Laws.

J. REPORTING:

No interim reports are required.
