1. <u>Meeting Opening and Introductions</u>

Chief Kevin Nord, Chairman, opened the meeting at approximately 2:05 p.m. The Chairman introduced himself, followed by the introductions of the Council members, Department of Fire Services' employees, and public members in attendance.

2. Approval of October 21, 2020 Meeting Minutes

Chief Mansfield made a motion to accept the meeting minutes from the previous meeting held on October 21, 2020. The motion was seconded by Undersecretary Thorpe. Motion to approve the minutes of the previous meeting was approved by unanimous roll call vote of the Council.

3. Old Business

a. Discuss and potential vote of the Matrix.

Director DiGregorio discusses the Matrix graph showing how the state regional teams will work. The county response wouldn't change as far as responding to the majority of the smaller events. The regional response is when further assets are needed. The local teams will feed into regional teams. Regions to include:

Region 1 – Norfolk, Bristol, Plymouth, Barnstable, add Dukes County and Nantucket County

Region 2 – Metro Boston / UASI

Region 3 District 7, 8.14

Region 4 – Western MA

Region 5 – Essex County referred to as Northeast Massachusetts Technical Rescue Team

Discussion on the number of meetings annually. Want to give teams more flexibility if they do not meet quarterly. Recommend changing to twice a year.

The membership committee approves the regional team membership. Subcommittees will advise the council.

Include SOPs and SOGs committee.

c. Discuss Tech Rescue Committee Correspondence. No correspondence.

d. Surveys distributed to the district team leaders. We have not received any additional survey information. Missing the regional team survey data for Region 3 District 14.

e. The Western Regional concept began after the hurricanes in Springfield. They formed it with the anticipation of a state run program. The biggest issue is funding for personnel. The smaller fire departments do not receive enough funding for the added training and support. The initial projection was within 5 years they would not be able to fund tech rescue. The team has felt it in morale and personnel numbers. They have been able to sustain equipment. They are going to have some trouble with equipment moving forward. Western MA Homeland Security is not funding for training. Their personnel numbers are dropping drastically.

4. New Business

a. HART Support Annex.

Chair Nord discusses the HART Support Annex. Helicopter hoisting response team. The team works with N. Carolina, S. Carolina to form the program. A group of handpicked individuals for training pilot. The team is capable of water related incidents. Financially

supported by EOPSS and Joint Base Cape Cod. Now funded by Plymouth County. This Annex is in final draft form that started before the council. Involving the council now to be transparent for the council to weigh in on the annex. It is our statutory responsibility to weigh in. Chair Nord made a motion to accept the HART Support Annex. Discussion on the next steps of the Annex with or without the council's vote. Mike Russas discusses the authorities included in the document to include the Tech Rescue Council. The council members would like some more time to review the document. Unanimous vote, Chief Mansfield was absent for the vote.

Discussion on draft budget documentation.

Vice Chair Iain McGregor discusses the draft budget documents sent for the meeting.

• Annual Budget – includes the five districts with draft numbers for team member size, stipends and other operational budget items.

Question: Is dive and swift water included in the training hours? We do believe that dive and swift water are included. There is no disagreement with dive and swift water being part of the Technical Rescue State Team.

• Capital Expense Policy – Create a basic plan / process that regional teams and submit to the Council. DFS can expend the funds when approved by the council.

• Regional Budget Policy – The council is the oversite to the regional teams. They can continue to run their team. Each region is provided a budget.

• Reimbursement Policy – Utilize DFS as the fiduciary. Maintain the flow chart document for expenses and purchases following the state/DFS purchasing policies.

DFS would be the record keeper.

The budget will continue to have items added to it to support the program.

Requested to have DFS look at the documents language and help identify where funding is going to come from.
