BIOFUEL SUPPLIERS LIST APPLICATION

Instructions

The Biofuel Supplier List is a list of entities that have been pre-approved to supply biofuel products to Generation Units, through a fuel distributor, participating in the Alternative Energy Portfolio Standard (APS). Examples of entities on the Biofuel Supplier List include: (1) biofuel suppliers, a person or entity who produces Eligible Liquid Biofuel from eligible feedstocks, or (2) biofuel wholesalers, a person or entity who purchases Eligible Liquid Biofuel from a biofuel supplier and sells it to a biofuel distributor. A biofuel distributor is a person or entity who sells Eligible Liquid Biofuel onto an end user. In order for a biofuel distributor to be eligible to receive Alternative Energy Certificates (AECs) under the APS, they must purchase their biofuel from a supplier or biofuel wholesaler on the Department's Biofuel Suppliers List.

Any biofuel supplier or wholesaler that wishes to be included on the Department's Biofuel Suppliers List must submit the following application to the Department. The Department shall review all applications and determine if the applicant meets all eligibility requirements prior to being placed on the list. To remain eligible, all entities listed on the Biofuel Suppliers List must reapply every year to ensure all eligibility requirements remain valid.

Biofuel Suppliers Only:

225 CMR 16.00 regulations requires that liquid biofuel suppliers must be registered in the Environmental Protection Agency's Renewable Fuel Standard (RFS2), 40 C.F.R. §§ 80.1400 - 80.1474, and must verify that they produce biodiesel from organic waste feedstocks. To meet these requirements, a liquid biofuel supplier must provide the following documentation with its application:

- 1) EPA Renewable Fuel Standard Attestation
- 2) Third Party Engineering Report, as submitted to the EPA RFS
- 3) Biofuel Feedstock Supply Plan, which may be either an EPA Separated Food Waste Plan (SFWP) or the template below

In addition to the above information on the Biofuel Feedstock Supply Plan, please provide evidence to support the description of the feedstock. This could include a contract agreement with the feedstock provider for the duration of the calendar year. It is permissible to provide an aggregation for the types of biofuels feedstocks, so long as the aggregation includes all of the same type of biofuel feedstock. For example, if used cooking oil is collected, it is not necessary to list every restaurant and the type of biofuel feedstock could be aggregated as "Used Cooking Oil". Note that the Department reserves the right to audit all documentation to verify fuel sources.
