TITLE: Statewide EMS Minimum Data Set

Purpose:

- 1) To define the minimum data elements pertaining to each EMS call that ambulance services must ensure their EMS personnel are documenting in trip records, as required by 105 CMR 170.345, and which ambulance services must timely submit to the Department of Public Health (Department), in accordance with 105 CMR 170.347, and this administrative requirement.
- 2) To define the minimum data elements that ambulance services are required to submit to the Department as template information at least annually, or as the information changes, in accordance with 105 CMR 170.347, and this administrative requirement.

Background:

Under M.G.L. c. 111C, §3(b)(15), the Department, as lead agency for EMS in the Commonwealth, is charged with the collection and maintenance of standardized patient data and information by ambulance services, which services must ensure their EMTs are collecting on a trip record. The minimum EMS data set defined in this Administrative Requirement (AR) is being updated to align with the most current version available nationally and is based on the National EMS Information System Dataset (NEMSIS), as set out in the [NEMSIS Data Dictionary Version 3.4.0](#). The MATRIS data dictionary is derived from the 585 elements in the NEMSIS V3.4.0 data dictionary.

Timeline:

(A) **Transition Period:** By February 28, 2019, the MATRIS NEMSIS V3.4.0 site will be live. At that point, ambulance services may begin submitting data, in accordance with all the requirements of this AR, directly to the MATRIS NEMSIS V3.4.0 website, <https://matrisv3.dph.state.ma.us/elite>, or import from third-party software that has passed NEMSIS V3.4.0 compliance testing for EMS agencies as documented on the NEMSIS website [here](#). However, **prior to beginning submission of NEMSIS V3.4.0 data, services must submit any NEMSIS V2.2.1 data they have not yet submitted, from January 1, 2013 forward.**

(B) Services may continue to submit NEMSIS V2.2.1 data until August 31, 2019, after which all services will be required to submit data in accordance with the new NEMSIS V3.4.0 standard, and all requirements of this AR.

The minimum information required by this AR for each EMS call must be submitted to the Department within 14 days of the call, via import or direct on-line data entry, to the MATRIS NEMSIS V3.4.0 website, at <https://matrisv3.dph.state.ma.us/elite>.

Data Elements

(A) Each NEMSIS V3.4.0 patient care report shall at a minimum include the following information about the EMS call that it documents. The definitions, values and configuration information for each of these elements are available in the Massachusetts Ambulance Trip Record Information System (MATRIS) NEMSIS V3.4.0 data dictionary, which can be found on the Department's website at
