- Connect to issue
- Make your "ask"
- Hold them accountable






Neuroscience Behind Storytelling

- Princeton study Uri Hasson
- Brain to Brain Coupling, through functional MRI
 - Brain light up when storytelling begins vs. typical conversation
- Evolutionarily programmed to learn from each other
- Storytelling causes better concentration and memory
- 1 (story) is greater than 10 million (pieces of data)

Chapter 257 investment: DDS increases




The Budget Timeline

- Governor releases in January
 - Previous fall is spent determining \$
- House Ways and Means, then the House
- Senate Ways and Means, then the Senate
- Conference Committee
- Vetoes (Governor)
- Overrides (Legislature)
- 9C cuts

Budget timeline






State Budget

- 56.1 billion 2.9% growth overall
- Chapter 257
- MassHealth, Long Term Support Services
- Department of Developmental Services
- DESE, and chapter 70

\$390 mil plus \$95 mil = \$485

- \$95 mil is coming from the Economic Development bill from last session
- Ensures that median direct care salaries will be no less than a median of \$20 per hour.



*Areas in orange denote spending appropriated on the FY22 Economic Development Bond Bill.

What does Chapter 257 investment mean for rates in 2025?

- The rates will be affected for residential services.
- Assumes the lowest model rate is no less than a median of \$20 per hour
- The rate reviews happen on a biennial basis, this year is residential
- In 2023 the funding was \$230 mil so this is a \$160 mil increase
- Last year was Community Day Programs and increases have made an impact on vacancy rates

Maintain these increases !

- Family Support 22% increase
- CBDS 26% increase
- T22 17% increase
- Transportation 19% increase
- Autism Adults- 18% increase
- Autism Children's Waiver a 10% increase (75 new families)
- Respite and technology investments
- 10 million for intensive residential for complex behavior/medical needs
- Nursing development and continuous nursing

Important messaging

- Thousands still waiting for services
- Globe reports neglect and abuse as autism grows
- No cuts!
- We must avoid the vicious circle!




<u>I'm Still Waiting</u>



The Arc opposes the MassHealth cuts in the program

- \$20.3 billion budget
- End of pandemic emergency federal fund ends
 - need to absorb \$1 billion
- Growing healthcare costs
 - PCA programs cuts affect 6,000
 - Meals prep time and those with less than 10 hours



Legislation is 2-year Cycle

- New session bills are filed in January
- House and Senate sponsors & Cosponsors
- Committee assignment and hearing
- Committee review
- Joint Rule deadline for committees to vote
- If favorable moves on to Ways and Means Committee, 3rd Reading, other committee
- Engrossed, enacted
- Governor signs into law

Legislative Priorities 4/4/24

- Expanding Nicky's Law In Ways and Means
- Hospital Training In Ways and Means
- Blue Envelope In Ways and Means
- Archaic Language Bill In Ways and Means
- Historical Records Bill In Ways and Means
- Medically Fragile Children In Ways and Means
- Tommy's Bill In Ways and Means
- Parents/Guardians as paid caregivers In Extension
- Supported Decision Making In Extension
- Police Training In Extension until 4/8
