Participants Tracey Nicholson from BXP, Erin Braley from BXP, and Alan Snow from BXP, Ken Staffier from VHB, Rick Dupuis from VHB, and Michael Muehe are sworn in. Exhibit #1 AAB 1-83 are noted. WJ is sworn in. WJ gives a brief background of this case, as the complainant did not arrive. Tracey Nicholson from BXP presents and notes that their team has installed signs indicating no parking or double parking at the curb cut as of October 29, 2024. Since then, she notes that they have given out 136 parking violations, 107 drops for the tow truck, and 165 complete tows since then. Erin Braley notes another measure they took as hashing the space in front of the curb cut with yellow lines, but it ended up confusing pedestrians. Rick Dupuis from VHB discusses the drop-off zone that they tried to work out with BXP. BXP shares some photographs of the site in question. Exhibit #2, a Google map image is noted. Discussion and questions of hearing.

Michael Muehe testifies on behalf of BCIL and clarifies that BXP owns both the road and the sidewalk. He suggests that a crosswalk could work between the Prudential Center and the entrance to Star Market. He does agree with using tall cones as a temporary measure but would advocate for something more permanent.
