## **DECISION**

EPW LLC D/B/A PRIME, YOUR LOCAL BUTCHER 1398 MASSACHUSETTS AVENUE ARLINGTON, MA 02476

EPW LLC d/b/a Prime, Your Local Butcher (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, November 12, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Quinn's Report.

#### **FACTS**

- 1. On Wednesday, July 24, 2019, at approximately 6:04 p.m., Investigators Di Cicco and Quinn ("Investigators") conducted an investigation of the business operation of EPW LLC d/b/a Prime, Your Local Butcher.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 24-ounce can of Pabst Blue Ribbon beer, for two dollars and ninetynine cents (\$2.99). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2012 with no prior violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
