#### **DECISION**

PARTHENON ENTERTAINMENT INC. D/B/A ADVENTURE PUB 190 MASSACHUSETTS AVENUE ARLINGTON, MA 02474

Parthenon Entertainment Inc. d/b/a Adventure Pub (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 12. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, November 5, 2019, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Quinn's Report.

The following documents are in evidence:

- 2. Licensee Stipulation of Fact;
- 3. Receipt for Alcohol Purchase;
- 4. Copy of New License Approval, 3/5/2019.

### **FACTS**

- 1. On Wednesday, July 24, 2019, at approximately 6:42 p.m., Investigators Di Cicco and Quinn ("Investigators") conducted an investigation of the business operation of Parthenon Entertainment Inc. d/b/a Adventure Pub.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a draught beer, for eight dollars and fifty-six cents (\$8.56). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 12 since March 2019 with no prior violations.

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch.138 § 34- Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. The Commission issues a **WARNING**.
