Ashby Market, Inc. (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, §15. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, October 25, 2016, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

- 1. Investigator Doyle's Compliance Check Field Report dated May 9, 2016; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Monday, May 9, 2016, at approximately 5:55 p.m., Investigators Bailey and Doyle investigated the business operation of Ashby Market, Inc.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a 25-oz. can Budweiser Light beer for two dollars and forty-nine cents (\$2.49). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence the Commission finds the Licensee violated 204 CMR 2.05 (2) - Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, §34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business over 20 years and with only one previous violation, the Commission issues a **WARNING**.
