The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, July 23, 2013, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an Illegality on the licensed premises, to wit: c. 138 §34 Sale or Delivery of an Alcoholic Beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the licensee stipulated to the violation alleged in Investigator Keefe's Report.

- An underage operative working with investigators purchased an alcoholic beverage, a can of Coors Light beer, for one dollar and eighty cents (\$1.80). The underage operative was not asked for identification.

## **CONCLUSION**
