



Overview




- Route 126 Roadway Reconstruction for safety improvements
- Scope consists of roadway widening to accommodate bicycle lanes and sidewalks on both sides of Pond Street
- The project begins at the south limit at the Holliston T.L. and continues north along Route 126 Pond Street in Ashland for 1.725 miles to the Framingham T.L.
- Requesting MassDOT Board approval of \$19.67M contract with Northern Constr Services LLC
- Construction will take approximately 3 years to complete;
 staged to maintain 1 lane of traffic in each direction

Existing Route 126 has poor drainage conditions





Construction Scope (cont'd) Massachusetts Department of Transportation Highway Division




Typical Section w/ proposed sidewalks and bike lanes

- Programmed in the CIP at \$19,569,554.00
- Engineers Estimate was \$17,186,250.00
- Bid Opening was September 1, 2020
