To accomplish this function, our clients provide us with necessary data about policy participants, including certain types of personal information. TMG places a high value on maintaining the integrity and security of the data we hold for clients. Regrettably, we write to inform you of a recent incident that may have involved your personal information, which was provided to TMG by <<ClientDef1(Client Name)>> in connection with the services we provide. This notice describes the incident, outlines the measures we have taken in response, and advises you on steps you can take to further protect your information.

On March 5, 2019, our ongoing investigation into a phishing email incident determined that an unauthorized person had obtained access to an email account belonging to a TMG employee. Upon first learning of the incident, we secured the employee's email account, launched an investigation to determine the nature and scope of the incident, and engaged a computer security firm to assist. The investigation determined that an unauthorized person had access to the employee's account from January 23 to January 24, 2019. The investigation was unable to determine the scope of information that may have been viewed or acquired by the unauthorized person. We therefore reviewed the full contents of the account for personal information. Our review found that an email or an attachment in the account contained some of your information, including your <<Cli>ClientDef2(Breach Details Variable Text)>>.

We are offering you a complimentary two-year credit monitoring membership with Experian's® IdentityWorksSM. This product helps detect the possible misuse of your personal information and provides you with identity protection support. A security freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a security freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a security freeze may delay your ability to obtain credit.

There is no fee to place or lift a security freeze. Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit reporting company. To request a security freeze, you will need to provide the following information:

- 2. Social Security number
- 3. Date of birth
- 4. If you have moved in the past five years, provide the addresses where you have lived over the prior five years
- 5. Proof of current address such as a current utility bill or telephone bill
- **6.** A legible photocopy of a government issued identification card (state driver's license or ID card, military identification, etc.)
- 7. If you are a victim of identity theft, include a copy of the police report, investigative report, or complaint to a law enforcement agency concerning identity theft

The credit reporting agencies have one business day after receiving your request by toll-free telephone or secure electronic means, or three business days after receiving your request by mail, to place a security freeze on your credit report. The credit bureaus must also send written confirmation to you within five business days and provide you with a unique personal identification number ("PIN") or password or both that can be used by you to authorize the removal or lifting of the security freeze.

To lift the security freeze in order to allow a specific entity or individual access to your credit report, or to lift a security freeze for a specified period of time, you must submit a request through a toll-free telephone number, a secure electronic means maintained by a credit reporting agency, or by sending a written request via regular, certified, or overnight mail to the credit reporting agencies and include proper identification (name, address, and Social Security number) and the PIN or password provided to you when you placed the security freeze as well as the identity of those entities or individuals you would like to receive your credit report or the specific period of time you want the credit report available. The credit reporting agencies have one business day after receiving your request by toll-free telephone or secure electronic means, or three business days after receiving your request by mail, to lift the security freeze for those identified entities or for the specified period of time.

To remove the security freeze, you must submit a request through a toll-free telephone number, a secure electronic means maintained by a credit reporting agency, or by sending a written request via regular, certified, or overnight mail to each of the three credit bureaus and include proper identification (name, address, and Social Security number) and the PIN number or password provided to you when you placed the security freeze. The credit bureaus have one business day after receiving your request by toll-free telephone or secure electronic means, or three business days after receiving your request by mail, to remove the security freeze.
