While we believe the risk of fraud is low, we want to help you feel safe and secure. We are enclosing some fraud prevention tools and tips and would like to offer you two (2) years of TransUnion's credit monitoring service at no cost to help you monitor your account for potential identity theft. You can sign up for this free service anytime until November 30, 2019. This service will not auto-renew and you'll have the choice if you'd like to keep it after two years. Please read the enclosed tips for how to set it up.

## TIPS FOR SAFEGUARDING YOUR PERSONAL INFORMATION:

1. As noted above, we have arranged for you to enroll, at no cost to you, in an online three-bureau credit monitoring service (myTrueldentity) for two years provided by TransUnion Interactive, a subsidiary of TransUnion®, one of the three nationwide credit reporting companies.

to a TransUnion representative if you believe you may be a victim of identity theft.

- To enroll in this service, go to the myTrueldentity website at <a href="www.mytrueldentity.com">www.mytrueldentity.com</a> and in the space referenced as "Enter Activation Code", enter the following unique 12-letter Activation Code listed below and follow the three steps to receive your credit monitoring service online within minutes.
- Once you are enrolled, you will be able to obtain two years of unlimited access to your TransUnion credit report and credit score. The daily three-bureau credit monitoring service will notify you if there are any critical changes to your credit files at TransUnion\*, Experian\* and Equifax\*, including fraud alerts, new inquiries, new accounts, new public records, late payments, change of address and more. The service also includes access to an identity restoration program that provides assistance in the event your identity is compromised to help you restore your identity and up to \$1,000,000 in identity theft insurance with no deductible. (Policy limitations and exclusions may apply.)
- You can sign up for the online or offline credit monitoring service anytime between now and November 30, 2019. Due to privacy laws, we cannot register you directly. Please note that credit monitoring services might not be available for individuals who do not have a credit file with TransUnion, Experian or Equifax, or an address in the United States (or its territories) and a valid Social Security number. Enrolling in this service will not affect your credit score.
- Review all your account statements thoroughly and promptly.
  - You should report any incidents of suspected identity theft to the relevant financial services provider and/or to local law enforcement.
- 3. Remain vigilant over the next 12 to 24 months.
- Request and review credit reports from each nationwide credit bureau noted below.
  - Once you receive your reports, review them for suspicious activity, such as inquiries from companies you did not contact, accounts you did not open, and debts on your accounts that you did not authorize.
  - Verify the accuracy of your social security number, address(es), complete name and employer(s).
  - Notify the credit bureaus if any information is incorrect in order to have it corrected or deleted.

An initial fraud alert stays on your credit report for 90 days and acts as an alert to potential lenders.

1. Special note for minors affected by this incident: The same services referred to above may not be available to affected minors. As an alternative, parents/legal guardians can check to see if your child may be a victim of identity theft by using TransUnion's secure online form at <a href="www.transunion.com/childidentitytheft">www.transunion.com/childidentitytheft</a> to submit your information so TransUnion can check their database for a credit file with your child's Social Security Number. After TransUnion's search is complete, they will respond to you at the email address you provide. If they locate a file in your child's name, they will ask you for additional information in order to proceed with steps to protect your child from any impact associated with this fraudulent activity.
