## NOTICE OF DATA BREACH

### WHAT HAPPENED

We write to inform you of an incident involving the compromise of VP Supply's computer systems that may have affected your personal information. VP Supply takes the privacy and security of your information seriously. We are writing to notify you of this incident and to let you know what you can do.

## WHAT YOU CAN DO

You may wish to take some or all of the below actions to help reduce your risk of identity theft.

Remain vigilant, especially over the next 12 months, and review your bank accounts, credit card bills and
free credit reports for unauthorized activity. Promptly report any suspected identity theft to your local
law enforcement agency, the U.S. Federal Trade Commission, the State Attorney General, your financial
institution, and to the Fraud Alert phone line of a consumer reporting agency. Telephone numbers for the

- Periodically obtain credit reports from each nationwide credit reporting agency and have information relating to fraudulent transactions deleted. We are offering free credit monitoring for a period of one year as outlined below.
- You have the right to obtain a police report regarding this incident. If you are the victim of identity theft, you also have the right to file a police report and obtain a copy of it.
- Place a fraud alert on your credit file by contacting any of the three credit reporting agencies listed above. A fraud alert temporarily, for a period of 90 days, requires potential creditors to take additional steps to verify identity before issuing credit in your name.
- Place a security freeze on your consumer report. A security freeze is designed to prevent credit, loans and services from being approved in your name without your consent. However, a security freeze may delay your ability to obtain credit. Pease contact one of the three credit reporting agencies above for further information.
