Re: Notice of Data Breach

I am writing to inform you of a data security incident experienced by Noveske Rifleworks, LLC ("Noveske") that may have affected your personal information. The privacy and security of your personal information is extremely important to Noveske. That is why I am writing to inform you of this incident, to offer you complimentary credit monitoring and identity theft restoration services, and to provide you with information relating to steps that can be taken to help protect your personal information.

What Happened? On May 13, 2020, Noveske learned of unusual activity within its email environment. Upon discovering this activity, Noveske immediately took steps to secure all Noveske email accounts and launched an investigation. As part of that investigation, Noveske engaged an independent digital forensics firm to determine what happened and whether any information was accessed or acquired without authorization as a result. As a result of this engagement, the digital forensics firm reported to Noveske that the email accounts of certain Noveske employees had been accessed without authorization. Following a review of the contents of the relevant email accounts, Noveske learned on August 21, 2020 that some of your personal information was contained therein which may have been accessed without authorization as a result of this incident. Noveske then worked diligently to identify up-to-date address information in order to provide notification to potentially impacted individuals.

Please note that this incident was limited to potential unauthorized access to information transmitted via <u>email</u> and did not affect any other Noveske information systems, including its core payroll and tax payment systems. Please also note that <u>Noveske also has no evidence to suggest that your information has been misused in connection with this incident</u>, but is nonetheless notifying you out of an abundance of caution.

What Information Was Involved? The information impacted in connection with this incident may have included your name, address, date of birth, online credentials, driver's license number or other state identification number, payment card information, financial account number, or routing number. Your Social Security number was not impacted in connection with this incident.

What Are We Doing? As soon as Noveske discovered this incident, Novseke took the measures described above. In addition, because Noveske takes the security of all information within its possession very seriously, Noveske notified law enforcement of this incident and took steps to enhance the security of its email system in order to minimize the likelihood of similar incidents occurring in the future. Noveske is also providing you with information about steps that you can take to help protect your personal information and is offering you complimentary MyIDCare<sup>TM</sup> services through ID Experts®, the data breach and recovery services expert. MyIDCare<sup>TM</sup> services include << twelve (12) / twenty-four (24) >> months of credit monitoring, dark web monitoring, a \$1,000,000 identity fraud loss reimbursement policy, and fully managed identity theft recovery services. ## STEPS YOU CAN TAKE TO HELP FURTHER PROTECT YOUR INFORMATION

Review Your Account Statements and Notify Law Enforcement of Suspicious Activity: As a precautionary measure, we recommend that you remain vigilant by reviewing your account statements and credit reports closely. If you detect any suspicious activity on an account, you should promptly notify the financial institution or company with which the account is maintained. You also should promptly report any fraudulent activity or any suspected incidence of identity theft to proper law enforcement authorities, your state attorney general, and/or the Federal Trade Commission (FTC).

Copy of Credit Report: You may obtain a free copy of your credit report from each of the three major credit reporting agencies once every 12 months by visiting <a href="http://www.annualcreditreport.com/">http://www.annualcreditreport.com/</a>, calling toll-free 877-322-8228, or by completing an Annual Credit Report Request Form and mailing it to Annual Credit Report Request Service, P.O. Fraud Alert: You may want to consider placing a fraud alert on your credit report. An initial fraud alert is free and will stay on your credit file for at least 90 days. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any accounts in your name. To place a fraud alert on your credit report, contact any of the three credit reporting agencies identified above. Security Freeze: You have the right to put a security freeze on your credit file. This will prevent new credit from being opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A security freeze is designed to prevent potential creditors from accessing your credit report without your consent. As a result, using a security freeze may interfere with or delay your ability to obtain credit. You must separately place a security freeze on your credit file with each credit reporting agency. There is no charge to place, lift or remove the security freeze. In order to place a security freeze, you may be required to provide the consumer reporting agency with information that identifies you including your full name, Social Security number, date of birth, current and previous addresses, a copy of your state-issued identification card, and a recent utility bill, bank statement or insurance statement.

Additional Free Resources: You can obtain information from the consumer reporting agencies, the FTC or from your respective state Attorney General about steps you can take toward preventing identity theft. You may report suspected identity theft to local law enforcement, including to the FTC or to the Attorney General in your state. Residents of Maryland, North Carolina, Rhode Island, and Washington, D.C. can obtain more information from their Attorneys General using the contact information below.

You also have certain rights under the Fair Credit Reporting Act (FCRA), including: to know what is in your file; to dispute incomplete or inaccurate information; to have consumer reporting agencies correct or delete inaccurate, incomplete, or unverifiable information, as well as others.
