## **Notice of Data Breach**

Dear Sample A. Sample:

We are writing to inform you of an incident that may have affected some of your personal information.

## What Happened

Nutmeg Advisory Group ("Nutmeg AG") was the victim of an email compromise that resulted in a third party gaining unauthorized access to one of Nutmeg AG's email accounts on May 5, 2020. As you may know, Nutmeg AG is a registered representative with Lincoln Financial Securities ("Lincoln") and it was the e-mail account assigned to Nutmeg AG by Lincoln that was compromised. Accordingly, an initial investigation into the breach was conducted by Lincoln, followed by a separate investigation by Nutmeg AG, during which we determined that your personal information may have been exposed due to this unauthorized access.

What Information Was Involved

Based on the facts known to Nutmeg AG at this time, the personal information affected by this unauthorized access may have included a combination of your [EXTRA1].

What We Are Doing

We take our obligation to safeguard the information we receive seriously. Once the incident was discovered we quickly took action to minimize risks, including securing the compromised email account and initiating an investigation into the unauthorized access. We are remaining vigilant, reporting any suspected phishing e-mails and will continue to screen e-mails carefully to avoid a similar incident in the future.

Free Credit Report. It is recommended that you remain vigilant by reviewing account statements and monitoring your credit report for unauthorized activity, especially activity that may indicate fraud and identity theft. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting agencies.

Fraud Alerts. There are two types of fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for at least one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft and you have the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. You can place a fraud alert on your credit report by contacting any of the three national credit reporting agencies.

Security Freeze. You have the ability to place a security freeze, also known as a credit freeze, on your credit report free of charge.

A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you may use an online process, an automated telephone line, or submit a written request to any of the three credit reporting agencies listed above. The following information must be included when requesting a security freeze (note that, if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past 5 years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, and display your name, current mailing address, and the date of issue.

If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state.
