This commitment extends to notifying clients if we believe the security or privacy of their information may have been compromised. To that end, we regret to inform you of an incident that may have involved some of your personal information.

We recently learned that an unauthorized third party gained access to our computer network. Upon identifying the issue, we initiated an internal investigation, and we hired a leading computer forensics firm to further examine our network and confirm the security of our computer systems. On October 6, 2020, we determined that, while the unauthorized party was in our network, it had the ability to view and extract certain documents related to loans that we have processed for clients, including you. These loan documents contained your name, mailing address, email address, Social Security Number, driver's license number and bank account number.

While we are not aware of any fraudulent activity or misuse of any client's information as a result of the incident, we are writing to alert you of what happened and to encourage you to diligently monitor your personal accounts.

Additionally, in an abundance of caution, we are offering you a complimentary two-year membership of Experian IdentityWorks<sup>SM</sup> Credit 3B. This product helps detect possible misuse of your personal information and provides you with identity protection services focused on immediate identification and resolution of identity theft. The alert informs creditors of possible fraudulent activity within your report and requests that the creditor contact you prior to establishing any new accounts in your name. Credit and Security Freezes: You may have the right to place a credit freeze, also known as a security freeze, on your credit file, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate the freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Unlike a fraud alert, you must separately place a credit freeze on your credit file at each credit reporting company.
