RE: Important Security Notification Please read this entire letter.

Dear \_\_\_\_\_

We are contacting you regarding a data security incident that has occurred on January 15, 2021 at First Financial Trust ("FFT"). This incident involved your name, account number and email address that may have been among the items stolen. As a result, your personal information may have been potentially exposed to others. Please be assured that we have taken every step necessary in investigating the incident.

It appeared that the IACOI Law Firm received a second set of wire instructions purporting to be from an Account Officer at First Financial Trust. The fraudulent email had your AOL email address and the account officer's email address with a fraudulent domain. The instructions mirrored the original instructions with the exception of the receiving bank listed as Huntington Bank in Cincinnati Ohio with a different routing number and account number.

FFT has blocked all communications from your email address and change the account number of the Estate of Clayton Robinson. The Account Officer changed her password and her system was scanned; no malware was detected. FFT will continue monitor future business transactions for suspicious activity.

To help protect your identity, we are offering a complimentary one-year membership of Experian's® IdentityWorks<sup>SM</sup>. This product provides you with superior identity detection and resolution of identity theft. To activate your membership and start monitoring your personal information please follow the steps below:
