**: Important Security Notification. Please read this entire letter.**

Dear <<Name 1>>:

APT Foundation, Inc. ("APT") recently discovered an incident that may affect the security of your personal information. We want to provide you with information about the incident, steps we are taking in response, and steps you may take to guard against identity theft and fraud, should you feel it is appropriate to do so.

**What Happened?** On December 22, 2023, an APT employee performing an internal test of certain APT systems inadvertently sent a file containing the information listed below to an unknown party. Upon discovery, the APT employee immediately attempted to recall the message using Microsoft's recall functionality. While we are not aware of and have no reason to suspect this information was misused in any way, we wanted to notify you out of an abundance of caution.

**What Information Was Involved?** As a result of the thorough investigation, we have identified the information that was impacted. The information that was exposed could have included your name and social security number.

**What We Are Doing?** We take the protection of your personal information seriously and are taking steps to prevent a similar occurrence. We took prompt action once we became aware of the incident, attempted to recall the inadvertently sent message, and engaged a leading law firm to advise us on our obligations to you.

**What You Can Do** We do not believe, and there are no facts to indicate, that this incident has resulted in a significant risk to you of identity theft or fraud. However, we recommend that you remain vigilant, review your account statements and credit reports regularly and report any concerns to your financial services provider. In addition, we are offering complementary credit monitoring services from Experian for <<<12/24>>> months. Please see the attached for instructions on how to access those services.

To help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for <<<12/24>>> months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

Please note that Identity Restoration is available to you for <<<12/24>>> months from the date of this letter and does not require any action on your part at this time. ### **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
