Notice of Security Incident

Dear [Redacted],

Baesman Group Inc. (“Baesman Group”) writes to inform you of an event that may affect the security of your personal information. Baesman group received your information because it provides services to health plans administered by Anthem Blue Cross and Blue Shield, Anthem Blue Cross, and Anthem HealthKeepers, or their affiliates¹. This letter provides details of the event, our response, and resources available to you to help protect your personal information from possible misuse, should you feel it is appropriate to do so.

What Happened. On May 31, 2023 and again in June 2023, Progress Software Corp. publicly disclosed security issues affecting the MOVEit Transfer tool. As a user of that tool, we moved quickly to take steps recommended by Progress to remedy the issues. We promptly launched an investigation to determine the potential impact of the issues on the security of data in the MOVEit Transfer server. Our ongoing investigation determined that an unknown actor improperly accessed the MOVEit Transfer server on May 29, 2023, and took certain data from the MOVEit Transfer server during that time. We then reviewed the data on the server at the time of the incident to determine who the data was related to and the contents for purposes of providing notice. We are notifying you because on or after January 29, 2024, your health plan confirmed data related to you was contained within the impacted files.

What Information Was Involved. Your First/Last Name, Address, Gender, Date of Birth, Phone, Language, Plan Benefit Package, Plan Type, Plan Name, CMS Member ID/Contract ID, Screening Information, Sensitive Services-Diagnosis,

Provider Name/NPI Number and other rewards related information may have been accessible due to the unauthorized access to the MOVEit Transfer server. Although we are currently unaware of any actual or attempted misuse of your personal information, we are providing you with this notice out of an abundance of caution.

What We Are Doing. We take this event and the security of personal information in our care very seriously. Upon learning of this event, we moved quickly to investigate and respond to the event and notify potentially affected individuals. As part of our ongoing commitment to the security of information, we are reviewing and enhancing our existing policies and procedures related to data privacy to reduce the likelihood of a similar future event.

What You Can Do. Please review the enclosed *Steps You Can Take to Help Protect Your Information*, which contains information on what you can do to better protect against possible misuse of your information. We encourage you to remain vigilant against potential incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious activity.

Steps You Can Take to Help Protect Your Information

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a credit freeze, you will need to provide the following information:

1. Full name (including middle initial, as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
