NOTICE OF DATA BREACH

Dear <<first_name>> <<middle_name>> <<last_name>> <<suffix>>,

First National Bankers' Bank ("FNBB") is writing on behalf of <<b2b_text_2 (Bank Name)>> to notify you of a data security incident that may have allowed an unauthorized individual to acquire personal information about you. You are receiving this letter because you have a checking account with <<b2b_text_2 (Bank Name)>>. We take the protection and proper use of your information very seriously. For this reason, you are being contacted directly to explain the circumstances of the incident.

What happened? <<b2b_text_2 (Bank Name)>> uses outside service providers for a variety of banking related services. As one of those service providers, FNBB clears checks written on or deposited to accounts at <<b2b_text_2 (Bank Name)>>. This process is performed by using scanned images of the checks submitted for processing. In this process, scanned images of checks are transferred between financial institutions. To transfer these images, FNBB utilizes a software tool called MOVEit Transfer, developed by Progress Software. In June 2023, FNBB was informed by Progress Software of a zero-day vulnerability that impacted data stored within our MOVEit Transfer server.

FNBB responded by swiftly applying 3 software patches provided by Progress Software and opening an investigation into that matter. We also notified law enforcement, and data forensic experts were hired to assist in our investigation. The investigation determined that unauthorized individuals had likely used the vulnerability to access FNBB's MOVEit server on May 27, 2023. This could have allowed the unauthorized individual to access files stored on the server, which may have included images of your checks and/or your checking account number.

On August 29, 2023, we were able to confirm the exact customer data impacted. <<b2b_text_2 (Bank Name)>> then engaged in a time-intensive review of the data to determine which customers were impacted. This review was recently completed.

What information was involved? Files stored on the MOVEit server included images of checks and checking account number information. In other words, potentially compromised information includes anything visible on the face or the back of the checks, including as applicable the account holder's name, address, routing number, account number, signature, and any other information on the checks.

What you can do. You should remain vigilant over the next 12 to 24 months for incidents of fraud and identity theft by reviewing account statements and monitoring your credit report for unauthorized activity. Promptly report incidents of suspected identity theft or suspicious activity to your bank. Also, review the enclosed "Additional Resources" section included with this letter. This section describes additional steps you can take to help protect yourself, including recommendations by the Federal Trade Commission and Credit Reporting Agencies regarding identity theft protection and details on how to place a fraud alert or a security freeze on your credit file. You can also ask us about preauthorized checks, ACH debit blocks, and other fraud prevention services.

What we are doing. Law enforcement and federal regulators have been notified regarding this incident. Three software patches provided by Progress Software have been applied in an effort to prevent future vulnerabilities, and FNBB is reviewing and updating its security policies and incident response plans to reduce the risk of similar events occurring in the future.

Credit Report Monitoring. In addition, FNBB has arranged with Kroll to provide you with credit monitoring for one year, at no cost to you. Kroll is a global leader in risk mitigation and response, and their team has extensive experience helping people who have sustained an unintentional exposure of confidential data. Your identity monitoring services include Credit Monitoring, a Current Credit Report, Web Watcher, Public Persona, Quick Cash Scan, \$1 Million Identity Fraud Loss Reimbursement, Fraud Consultation, and Identity Theft Restoration.

Free Credit Report. It is recommended that you remain vigilant by reviewing account statements and monitoring your credit report for unauthorized activity, especially activity that may indicate fraud and identity theft. You may obtain a copy of your credit report, free of charge, once every 12 months from each of the three nationwide credit reporting agencies.

For Colorado, Georgia, Maine, Maryland, Massachusetts, New Jersey, Puerto Rico, and Vermont residents:

You may obtain one or more (depending on the state) additional copies of your credit report, free of charge. You must contact each of the credit reporting agencies directly to obtain such additional report(s).

Fraud Alerts. There are two types of fraud alerts you can place on your credit report to put your creditors on notice that you may be a victim of fraud—an initial alert and an extended alert. You may ask that an initial fraud alert be placed on your credit report if you suspect you have been, or are about to be, a victim of identity theft. An initial fraud alert stays on your credit report for at least one year. You may have an extended alert placed on your credit report if you have already been a victim of identity theft and you have the appropriate documentary proof. An extended fraud alert stays on your credit report for seven years. You can place a fraud alert on your credit report by contacting any of the three national credit reporting agencies.

Security Freeze. You have the ability to place a security freeze, also known as a credit freeze, on your credit report free of charge.

A security freeze is intended to prevent credit, loans and services from being approved in your name without your consent. To place a security freeze on your credit report, you may use an online process, an automated telephone line, or submit a written request to any of the three credit reporting agencies listed above. The following information must be included when requesting a security freeze (note that, if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past 5 years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, and display your name, current mailing address, and the date of issue.

Federal Trade Commission and State Attorneys General Offices. If you believe you are the victim of identity theft or have reason to believe your personal information has been misused, you should immediately contact the Federal Trade Commission and/or the Attorney General's office in your home state. You may also contact these agencies for information on how to prevent or minimize the risks of identity theft.

Reporting of identity theft and obtaining a police report.

For Iowa residents: You are advised to report any suspected identity theft to law enforcement or to the Iowa Attorney General.

For Massachusetts residents: You have the right to obtain a police report if you are a victim of identity theft.

For Oregon residents: You are advised to report any suspected identity theft to law enforcement, the Federal Trade Commission, and the Oregon Attorney General.



TAKE ADVANTAGE OF YOUR IDENTITY MONITORING SERVICES

You have been provided with access to the following services from Kroll:

Triple Bureau Credit Monitoring and Single Bureau Credit Report

Your current credit report is available for you to review. You will also receive alerts when there are changes to your credit data at any of the three national credit bureaus—for instance, when a new line of credit is applied for in your name. If you do not recognize the activity, you will have the option to call a Kroll fraud specialist, who will be able to help you determine if it is an indicator of identity theft.

Web Watcher

Web Watcher monitors internet sites where criminals may buy, sell, and trade personal identity information. An alert will be generated if evidence of your personal identity information is found.

Public Persona

Public Persona monitors and notifies when names, aliases, and addresses become associated with your Social Security number. If information is found, you will receive an alert.

Quick Cash Scan

Quick Cash Scan monitors short-term and cash-advance loan sources. You will receive an alert when a loan is reported, and you can call a Kroll fraud specialist for more information.

\$1 Million Identity Fraud Loss Reimbursement

Reimburses you for out-of-pocket expenses totaling up to \$1 million in covered legal costs and expenses for any one stolen identity event. All coverage is subject to the conditions and exclusions in the policy.

Fraud Consultation

You have unlimited access to consultation with a Kroll fraud specialist. Support includes showing you the most effective ways to protect your identity, explaining your rights and protections under the law, assistance with fraud alerts, and interpreting how personal information is accessed and used, including investigating suspicious activity that could be tied to an identity theft event.

Identity Theft Restoration

If you become a victim of identity theft, an experienced Kroll licensed investigator will work on your behalf to resolve related issues. You will have access to a dedicated investigator who understands your issues and can do most of the work for you. Your investigator will be able to dig deep to uncover the scope of the identity theft, and then work to resolve it.

Kroll's activation website is only compatible with the current version or one version earlier of Chrome, Firefox, Safari and Edge.

To receive credit services, you must be over the age of 18 and have established credit in the U.S., have a Social Security number in your name, and have a U.S. residential address associated with your credit file.
