**NOTICE OF [Extra1]**

Dear Sample A. Sample:

Newman Ferrara LLP (“Newman Ferrara”) is writing to inform you of a recent incident that may impact the security of some of your personal information. While we are unaware of any attempted or actual fraudulent use of your information, we are providing you with information about the incident, our response, and steps you may take to protect against potential misuse of your information, should you wish to do so.

**What Happened?** On February 9, 2024, Newman Ferrara discovered suspicious activity on our servers. We immediately launched an investigation, with the assistance of third-party forensic specialists, to determine the nature and scope of the activity. Our investigation determined that there was unauthorized access to certain systems in our environment on or about February 8, 2024 to February 9, 2024, and during this time an unauthorized actor copied certain files from these systems. We then undertook a comprehensive review of the data at risk to determine what information was contained therein and to whom it related. We subsequently determined that information related to you may have been impacted by this incident.

**What Information Was Involved?** The information relating to you that may have been impacted by this incident could include your name, social security number, driver’s license number, financial account information, health insurance information or medical history, and/or other information to the extent provided to Newman Ferrara in connection with your employment.

**What We Are Doing.** Newman Ferrara takes the confidentiality, privacy, and security of information in our care very seriously. Upon discovering the issue, we immediately commenced an investigation to confirm the nature and scope of the incident, and to identify what information could have been affected.

As an added precaution, we are offering you access to [Extra3] months of complimentary credit monitoring and identity protection services through Experian at no cost to you. A description of the services and instructions on how to enroll can be found within the enclosed *Steps You Can Take to Protect Personal Information*. Please note that you must complete the enrollment process yourself as we are not permitted to enroll you in these services.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements; enrolling in the complimentary services provided by Experian IdentityWorks which includes credit monitoring, identity restoration, and \$1 Million identity Theft Insurance; and monitoring your free credit reports for suspicious activity and to detect errors over the next 12 to 24 months.

### Enroll in Monitoring Services

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number; Social Security card, pay stub, or W-2;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect your personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
