We immediately engaged third-party forensic specialists to assist us with securing the network environment and investigating the extent of any unauthorized activity. While our investigation, which concluded February 6, 2024, uncovered no forensic evidence of any acquisition of data, it determined an unauthorized third party may have accessed certain individual personal information during this incident.

We found no evidence that your information has been specifically misused; however, it is possible that the following personal information could have been accessed by an unauthorized third party: first and last name, Blackburrn email address, Blackburn email address password. This information was maintained for standard enrollment and administrative purposes.

Again, to date, we have not received information of any misuse of personal information.

Blackburn College takes the privacy of personal information seriously and wants to provide you with information and resources you can use to protect your information.

What Happened and What Information Was Involved:

On December 14, 2023, we detected and stopped a network security incident, in which an unauthorized third party accessed and disabled some of our systems. We immediately engaged third-party forensic specialists to assist us with securing the network environment and investigating the extent of any unauthorized activity. While our investigation, which concluded February 6, 2024, uncovered no forensic evidence of any acquisition of data, it determined an unauthorized third party may have accessed certain individual personal information during this incident.

We found no evidence that your information has been specifically misused; however, it is possible that the following personal information could have been accessed by an unauthorized third party: first and last name and Social Security number. This information was maintained for standard payroll and organizational purposes.

Again, to date, we have not received information of any misuse of personal information.

What We Are Doing:

Data security is one of our highest priorities. Upon detecting this incident, we moved quickly to initiate a response, which included conducting an investigation with the assistance of IT specialists and confirming the security of our network environment. We communicated with law enforcement. We wiped and rebuilt affected systems and have taken steps to bolster our network security. We are also reviewing our policies related to security.

We are offering you with access to Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score services at no charge. These services provide you with alerts for twelve months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided through Identity Force, a TransUnion company specializing in fraud assistance and remediation services.

What You Can Do:

То enroll in Credit Monitoring services at no charge, please log on to https://secure.identityforce.com/benefit/blackburn and follow the instructions provided. When prompted please provide the following unique code to receive services: **ZEMCRHHGHB** In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

We encourage you to take full advantage of this service offering. TransUnion representatives have been fully versed on the incident and can answer questions or concerns you may have regarding protection of your personal information.

Enclosed you will find additional information regarding the resources available to you, and the steps that you can take to further protect your personal information.

Credit Reports: You may obtain a copy of your credit report, free of charge, whether or not you suspect any unauthorized activity on your account. You may obtain a free copy of your credit report from each of the three nationwide credit reporting agencies. You may make that request by certified mail, overnight mail, regular stamped mail, or by following the instructions found at the websites listed below. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse or a minor under the age of 16, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue. As of September 21, 2018, it is free to place, lift, or remove a security freeze.
