**Re: Data Security Incident**

Dear ,

Denver Academy recently detected a data security incident that may have resulted in unauthorized access to some individuals' personal information. This notice is intended to provide details about the incident, steps we are taking in response, and resources available to help protect against the potential misuse of personal information.

### **What Happened?**

On December 29, 2023, Denver Academy detected suspicious activity on its network. An unauthorized third party attempted to infiltrate Denver Academy's network and gained access from December 24, 2023 to December 29, 2023. Upon discovery of this incident, Denver Academy immediately disconnected all access to the network and promptly engaged a specialized third-party cybersecurity firm and IT personnel to assist with securing the environment, as well as to conduct a forensic investigation to determine the nature and scope of the incident.

The forensic investigation, which concluded on January 29, 2024, determined that certain systems may have been compromised by an unauthorized actor. Based on these findings, Denver Academy performed a review of the affected systems to identify the specific individuals and the types of information that may have been compromised. On February 20, 2024, Denver Academy finalized the list of individuals to notify, followed by organizing the mailing, call center, and credit monitoring services for the impacted population. This process was necessary to provide accurate information and notice to the potentially impacted individuals.

### **What Information Was Involved?**

Denver Academy has no evidence that any sensitive information has been misused by third parties as a result of this incident. Based on the investigation, the following information related to you may have been subject to unauthorized access: name, date of birth, and driver's license number. **No Social Security numbers were impacted.** Please note that the information varies among potentially impacted individuals and the information listed above varies among current and former employees who were potentially impacted.

### **What We Are Doing:**

Data privacy and security is among Denver Academy's highest priorities, and we are committed to doing everything we can to protect the privacy and security of the personal information in our care. Since the

discovery of the incident, Denver Academy moved quickly to investigate, respond, and confirm the security of our systems. Specifically, Denver Academy engaged a specialized cybersecurity firm and IT personnel to conduct a forensic investigation to determine the nature and scope of the incident. Additionally, Denver Academy also disconnected all access to their network, changed administrative credentials, restored operations in a safe and secure mode, enhanced security measures, and took steps and will continue to take steps to mitigate the risk of future harm.

In response to the incident, we are providing you with access to **Single Bureau Credit Monitoring/Single Bureau Credit Report/Single Bureau Credit Score** services at no charge. These services provide you with alerts for 12 months from the date of enrollment when changes occur to your credit file. This notification is sent to you the same day that the change or update takes place with the bureau. Finally, we are providing you with proactive fraud assistance to help with any questions that you might have or in event that you become a victim of fraud. These services will be provided by CyberScout through Identity Force, a TransUnion company specializing in fraud assistance and remediation services.

How do I enroll for the free services?

To enroll in Credit Monitoring services at no charge, please log on to <https://secure.identityforce.com/benefit/denveracademy> and follow the instructions provided. When prompted please provide the following unique code to receive services: [REDACTED]

In order for you to receive the monitoring services described above, you must enroll within 90 days from the date of this letter. The enrollment requires an internet connection and e-mail account and may not be available to minors under the age of 18 years of age. Please note that when signing up for monitoring services, you may be asked to verify personal information for your own protection to confirm your identity.

In addition to enrolling in the services described above, we encourage you to remain vigilant against incidents of identity theft and fraud, to review your account statements, and to monitor your credit reports for suspicious or unauthorized activity. Additionally, security experts suggest that you contact your financial institution and all major credit bureaus to inform them of such a breach and then take whatever steps are recommended to protect your interests, including the possible placement of a fraud alert on your credit file.
