Heritage Insurance Holdings Inc. (“Heritage”) takes the security of personal information seriously. While we have no indication that your personal information has been misused, we are writing to inform you of an incident and provide you with resources available to you to help protect your information, should you feel it necessary to do so.

What Happened? On March 7, 2021, Heritage’s IT team noticed some malicious activity on several servers. Heritage immediately launched an investigation to confirm the full nature and scope of the incident and restore functionality to impacted systems. On or about March 22, 2021, we discovered that certain information stored within the Heritage environment had been accessed and/or acquired by an unknown actor between March 4, 2021 and March 8, 2021. We confirmed that a limited amount of your personal information was present in the impacted files.

What Information Was Involved? The investigation determined that the following types of information related to you could be involved, including your name, and [EXTRA1]. Your information may have been in our system as an employee, former employee or family member to an employee.

What We Are Doing. Upon discovering this incident, we moved quickly to investigate and respond, assess the security of relevant Heritage systems, and identify any impacted data. We also notified federal law enforcement about this event. As part of our ongoing commitment to the security of information, we are also reviewing our policies and procedures to examine existing security measures.

While we have no evidence of any misuse of your information related to this event, we would like to offer you access to complimentary credit monitoring services for 24 months through Experian. These services include fraud consultation and identity theft restoration services. If you wish to activate the credit monitoring services, you may follow the instructions included in the *Steps You Can Take to Help Protect Your Information*.

Steps You Can Take to Help Protect Personal Information

Enroll in Complimentary Credit Monitoring

To help protect your identity, we are offering complimentary access to Experian IdentityWorksSM for 24 months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. Monitor Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit "prescreened" offers of credit and insurance you get based on information in your credit report; and you may seek damages from violator. You may have additional rights under the Fair Credit Reporting Act not summarized here. Identity theft victims and active duty military personnel have specific additional rights pursuant to the Fair Credit Reporting Act.
