Dear Sample A. Sample:

As you may know, Carolina Eastern, Inc. (“Carolina Eastern”) was a victim of a sophisticated cybersecurity incident known as a ransomware attack. We are writing to notify you that some of your personal information may have been affected by this incident.

Ransomware is a form of malware that is used by hackers to prevent users from accessing files, and in some cases, extract and hold data hostage with a threat to publish it until a ransom is paid. In this case, a sophisticated group of cyber criminals, known as the DarkSide group, is claiming responsibility for the attack. While Carolina Eastern was aware it experienced some computer operations interruptions on April 23, 2021, it was not until May 11, 2021 that it understood it had been a victim of DarkSide.

*Carolina Eastern has worked diligently combing through our systems to determine the extent of this incident and now we are notifying you out of an abundance of caution that your information may have been impacted and are providing you with two years free credit monitoring at no cost to you.*

**What We Are Doing**

After learning of the incident, we quickly took action to contain the threat, secure our systems, and restore affected devices. We are continuing to investigate the incident and have retained leading outside security experts to determine the nature and scope of the incident. We also reported this incident to the FBI Cyber Crimes Division and are working with federal law enforcement regarding this incident. We are making improvements to our security systems and operations to increase security across Carolina Eastern.

**What Information Was Involved**

Based on our investigation, we believe that the cyber criminals may have accessed and acquired certain employment-related records stored on the affected Carolina Eastern systems, such as social security number, driver’s license, date of birth, and address. While we are not certain what information may have been impacted by this event, we are notifying you out of an abundance of caution that your information may have been obtained by the threat actors.

## What You Can Do



You are entitled to one free credit report annually from each of the three nationwide consumer reporting agencies. We encourage you to remain vigilant by reviewing your account statements and monitoring your free credit reports.

**In addition, we have arranged to offer credit monitoring and identity restoration services from Experian at no cost to you.** The enclosed Reference Guide provides more information about the services and how to register for them, requesting credit reports, and additional recommendations on the protection of personal information.

We encourage affected individuals to take the following steps:

**Register for Credit Monitoring and Identity Restoration Services.** To help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for 24 months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

### **Monitor Your Accounts**

We recommend that you regularly review statements from your accounts and periodically obtain your credit report from one or more of the national credit reporting companies. You may obtain a free copy of your credit report online at [www.annualcreditreport.com](http://www.annualcreditreport.com), by calling toll-free 1-877-322-8228, or by mailing an Annual Credit Report Request Form (available at [www.annualcreditreport.com](http://www.annualcreditreport.com)) to Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA, 30348-5281. You may also purchase a copy of your credit report by contacting one or more of the three national credit reporting agencies listed below.

When you receive your credit reports, review them carefully. Look for accounts or creditor inquiries that you did not initiate or do not recognize. Look for information, such as home address and Social Security number that is not accurate. If you see anything you do not understand, call the credit reporting agency at the telephone number on the report.

### **Credit Freeze**

You have the right to put a security freeze, also known as a credit freeze, on your credit file, so that no new credit can be opened in your name without the use of a Personal Identification Number (PIN) that is issued to you when you initiate a freeze. A credit freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a credit freeze, potential creditors and other third parties will not be able to access your credit report unless you temporarily lift the freeze. Therefore, using a credit freeze may delay your ability to obtain credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. Should you wish to place a credit freeze, please contact all three major consumer reporting agencies listed below.

You must separately place a credit freeze on your credit file at each credit reporting agency. The following information should be included when requesting a credit freeze:

- 1) Full name, with middle initial and any suffixes;
- 2) Social Security number;
- 3) Date of birth (month, day, and year);
- 4) Current address and previous addresses for the past five (5) years;
- 5) Proof of current address, such as a current utility bill or telephone bill;
- 6) Other personal information as required by the applicable credit reporting agency;

If you request a credit freeze online or by phone, then the credit reporting agencies have one (1) business day after receiving your request to place a credit freeze on your credit file report. If you request a lift of the credit freeze online or by phone, then the credit reporting agency must lift the freeze within one (1) hour. If you request a credit freeze or lift of a credit freeze by mail, then the credit agency must place or lift the credit freeze no later than three (3) business days after getting your request.

### **Fraud Alerts**

You also have the right to place an initial or extended fraud alert on your file at no cost. An initial fraud alert lasts 2 years and is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting 7 years. Should you wish to place a fraud alert, please contact any one of the agencies listed below. The agency you contact will then contact the other two credit agencies.

### **Monitor Your Personal Health Information**

If applicable to your situation, we recommend that you regularly review the explanation of benefits statement that you receive from your insurer. If you see any service that you believe you did not receive, please contact your insurer at the number on the statement. If you do not receive the regular explanation of benefits statements, contact your provider and request them to send such statements following the provision of services in your name or number.

You may want to order copies of your credit reports and check for any medical bills that you do not recognize. If you find anything suspicious, call the credit reporting agency at the phone number on the report. Keep a copy of this notice for your records in case of future problems with your medical records. You may also want to request a copy of your medical records from your provider, to serve as a baseline. If you are a California resident, we suggest that you visit the website of the California Office of Privacy Protection at [www.privacy.ca.gov](http://www.privacy.ca.gov) to find more information about your medical privacy.

### **Additional Information**

You can further educate yourself regarding identity theft and the steps you can take to protect yourself, by contacting your state Attorney General or the Federal Trade Commission. Instances of known or suspected identity theft should be reported to law enforcement, your Attorney General, and the FTC.
