Marlabs is writing to inform you that a data security incident may have affected your personal information on June 20, 2021.

## **What Information Was Involved**

While we have no indication at this time that any of your personal information has been misused, we have determined that the unauthorized access to your personal information may have occurred, including your: name, address, email address, phone number, date of birth, location of birth, social security number, financial account information, passport number, health insurance information, visa number and other immigration application information.

### What We Are Doing

We take the privacy and security of data seriously. We have notified law enforcement and are working with cybersecurity counsel to determine the actions to take in response to this incident.

In addition, and as a safeguard, we have arranged for you to enroll in a complimentary, identity theft protection services through IDX, the data breach and recovery services expert. IDX identity protection services include: twenty-four (24) months of credit monitoring. Again, we have no indication that your personal information has been misused as a result of this incident and are offering this service out of an abundance of caution for the peace of your mind.

Once you are enrolled, you will be able to obtain twenty-four (24)months of the daily credit monitoring service that will notify you if there are any critical changes to your credit file at TransUnion, including fraud alerts, new inquiries, new accounts, new public records, late payments, changes of address, and more.
