Northeast Rehabilitation Hospital Network (“NRHN”) is writing to inform you of an event that may impact the privacy of some of your personal information. **While we are unaware of any attempted or actual misuse of your information, we are providing you with information** about the event, our response, and information related to what you may do to better protect your information, should you feel it necessary to do so.

What Happened? On September 30, 2021, NRHN became aware of suspicious activity related to its systems and immediately launched an investigation to determine the nature and scope of the activity. The investigation determined that an unauthorized individual gained access to certain NRHN systems between September 30, 2021 and October 5, 2021, and accessed certain information stored on those systems. We then proceeded to conduct a thorough and time-intensive review of the impacted information to ensure we identified all individuals with information potentially at risk, which was completed on August 3, 2022. Although NRHN is unaware of any actual or attempted misuse of individuals’ information, NRHN is providing notice of this event to individuals who were identified through the comprehensive data review.

What Information Was Involved? Our investigation determined that the following types of your information were included in the impacted files: name, <<Breached Elements>>.

What We Are Doing. We take this incident and the security of personal information in our care very seriously. Upon discovery, NRHN immediately took steps to ensure the security of our systems and investigate the event. Notice of the event was provided to local and national media outlets and posted on the Northeast Rehabilitation website. As part of our ongoing commitment to the privacy of information in our care, we have implemented additional technical security measures to strengthen the security of our systems. We also have reviewed and enhanced existing data privacy policies and procedures. We immediately notified the FBI and other regulatory bodies of this incident and are updating additional agencies as required.

As an added precaution we are offering you access to <<CM Length>> months of credit monitoring and identity theft protection services through Epiq at no cost to you. Enrollment instructions are enclosed with this letter. We encourage you to enroll in these services as we are unable to act on your behalf to do so.

What You Can Do. We encourage you to remain vigilant against incidents of identity theft and fraud, to monitor your accounts for any unusual activity, and to report any instances of theft or fraud to law enforcement. Please review the enclosed *Steps You Can Take to Help Protect Personal Information* for useful information on what you can do to better protect against possible misuse of your information. You can also enroll to receive the complimentary credit monitoring services that we are offering to you.

Monitor Your Accounts

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit www.annualcreditreport.com or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

¹ WebScan searches for your Social Security Number, up to 5 passport numbers, up to 6 bank account numbers, up to 6 credit/debit card numbers, up to 6 email addresses, and up to 10 medical ID numbers. WebScan searches thousands of Internet sites where consumers’ personal information is suspected of being bought and sold, and regularly adds new sites to the list of those it searches. However, the Internet addresses of these suspected Internet trading sites are not published and frequently change, so there is no guarantee that we are able to locate and search every possible Internet site where consumers’ personal information is at risk of being traded.

² The Automatic Fraud Alert feature is made available to consumers by Equifax Information Services LLC and fulfilled on its behalf by Equifax Consumer Services LLC.

³ Locking your Equifax credit report will prevent access to it by certain third parties. Locking your Equifax credit report will not prevent access to your credit report at any other credit reporting agency. Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

Further, pursuant to the Fair Credit Reporting Act, the consumer reporting bureaus must correct or delete inaccurate, incomplete, or unverifiable information; consumer reporting agencies may not report outdated negative information; access to your file is limited; you must give your consent for credit reports to be provided to employers; you may limit “prescreened” offers of credit and insurance you get based on information in your credit report; and you may seek damages from violator. You may have additional rights under the Fair Credit Reporting Act not summarized here.
