## NOTICE OF DATA INCIDENT

Dear Sample A. Sample:

North Star Leasing, a division of Peoples Bank of Marietta, Ohio ("We" or "North Star") is writing to inform you about a recent event that may impact the privacy of some of your personal information. We are providing you with details about the event, steps we have taken in response, and resources available to assist you with safeguarding your information, should you feel it is appropriate to do so. We value and respect the privacy and security of the information entrusted to us. As such, upon becoming aware of the event, we promptly began a comprehensive investigation and worked diligently to confirm its potential impact on our systems and data.

Our investigation has not revealed evidence of identity theft or fraud. Nevertheless, we are offering you 24 months of complimentary credit monitoring services through Experian as an added precaution; enrollment instructions are provided below. Additionally, there are several steps individuals can take to protect themselves and remain vigilant against incident theft and fraud following any data privacy event. These steps include reviewing your bank account statements, credit reports, and monitoring your tax return status for suspicious activity and to detect errors.

You may also enroll in the complimentary credit monitoring services being offered to you. Due to privacy restrictions, we are unable to act on your behalf, so if you would like to enroll in these services, please do so by following the instructions immediately below:

## **Enroll in Credit Monitoring**

To help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for 24 months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. If, after discussing your situation with an agent, it is determined that identity restoration support is needed then an Experian Identity Restoration agent is available to work with you to investigate and resolve each incident of fraud that occurred from the date of the incident (including, as appropriate, helping you with contacting credit grantors to dispute charges and close accounts; assisting you in placing a freeze on your credit file with the three major credit bureaus; and assisting you with contacting government agencies to help restore your identity to its proper condition).

A credit card is not required for enrollment in Experian IdentityWorks. You can contact Experian immediately regarding any fraud issues, and have access to the following features once you enroll in Experian IdentityWorks:

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a one-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any

other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

- 1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
- 2. Social Security number;
- 3. Date of birth:
- 4. Addresses for the prior two to five years;
- 5. Proof of current address, such as a current utility bill or telephone bill;
- 6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
- 7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.

If you are the victim of identity theft, you also have the right to file a police report and obtain a copy of it.
