## NOTICE OF SECURITY INCIDENT

Dear Sample A. Sample,

Amotec, Inc. ("Amotec") is writing to notify you of an incident that occurred on our systems that may have impacted the privacy of some of your personal information. We sincerely apologize that this incident occurred, and are providing you with information about the incident, our response to it, and resources we are making available to you to help protect your information, should you wish to do so. Due to requirements imposed by Massachusetts law, we are unable to provide further detail about the nature of this incident, but you may obtain additional information by calling the dedicated assistance line included at the end of this letter.

As a precaution, we are offering credit monitoring and identity protection services for 24 months through Experian, at no cost to you. The deadline to enroll in these services is May 31, 2023. Please note that you will not be automatically enrolled in these services. Should you wish to do so, you will need to enroll yourself in these services, as we are not able to do so on your behalf. You may find instructions on how to enroll below.

To help protect your identity, we are offering complimentary access to Experian IdentityWorks<sup>SM</sup> for 24 months.

If you believe there was fraudulent use of your information as a result of this incident and would like to discuss how you may be able to resolve those issues, please reach out to an Experian agent. - 7. Social Security Card, pay stub, or W-2; and/or
- 8. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
