We write to inform you of an issue that may have involved some of your personal information.

What Happened?

Due to an error in processing, your address was changed by mistake. This caused a copy of your transaction confirmation, dated February 17, 2023, to be mailed to an unauthorized individual.

What Information Was Involved?

The transaction confirmation contained you name, address, contract number, and financial values.

What We Are Doing.

We are taking this incident very seriously. We have provided coaching and training to the responsible party. We will continue to closely monitor and take further steps as appropriate to safeguard your personal information.

What You Can Do.

It is always a good practice to be vigilant and closely review or monitor your financial accounts, statements, credit reports and other financial information for any evidence of unusual activity, fraudulent charges or signs of identity theft. Additionally, changing your password and security questions and enrolling in dual-factor authentication on all your accounts may assist in protecting against identity theft. Additional Information About Security Freezes. You also have a right to place a "security freeze" on your credit report at no charge, which will prohibit a consumer reporting agency from releasing information in your credit report without your express authorization. The security freeze is designed to prevent credit, loans and services from being approved in your name without your consent. However, you should be aware that using a security freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. In addition, a security freeze does not apply to a person or entity, or its affiliates, or collection agencies acting on behalf of the person or entity, with which you have an existing account that requests information in your credit report for the purposes of reviewing or collecting the account. Reviewing the account includes activities related to account maintenance, monitoring, credit line increases, and account upgrades and enhancements.

If you wish to place a security freeze on your credit file, you must separately place a security freeze on your credit file at each credit reporting agency. In order to place a security freeze, you may need to provide the following information: (1) Full name (including middle initial as well as Jr., Sr., II, III, etc.); (2) Social Security Number; (3) Date of birth; (4) Addresses for the prior five years; (5) Proof of current address; and (6) A legible copy of a government issued identification card.
