## NOTICE OF DATA BREACH

Genova Burns LLC (“Genova Burns”) is writing to notify you of a recent data security incident that may have impacted your personal information, which is in our possession due to our legal representation of Uber Technologies, Inc. In connection with this legal representation, we received data regarding certain drivers on the Uber platform, which included information about you. We want to provide you with information about the incident, our response, and steps you may take to better help protect against possible misuse of your personal information.

**What Happened?** On January 31, 2023, Genova Burns became aware of suspicious activity relating to our internal information systems. In response, we engaged outside forensic and data security specialists to investigate the nature and scope of the activity. We determined that an unauthorized third party gained access to our systems and certain limited files were accessed or exfiltrated between January 23, 2023 and January 31, 2023. In response, we undertook a comprehensive review to determine what was impacted. On March 1, 2023, we determined that information related to you was contained in an impacted file, after which we notified Uber. At this time, we are unaware of any actual or attempted misuse of your information as a result of this incident.

**What Information Was Involved?** The investigation determined that information you provided to Uber, including your name and Social Security number and/or Tax Identification number, was among the impacted data.

**What We Are Doing.** The confidentiality, privacy, and security of personal information within our care is important to us. Upon learning of the event, we investigated to determine the nature and scope of the incident and secured the environment by changing all system passwords. We also notified law enforcement and are cooperating with its investigation. We will be taking additional steps to improve security and better protect against similar incidents in the future. As an added precaution, Genova Burns is offering you access to 24 months of complimentary identity monitoring services through Kroll. Details of this offer and instructions on how to activate the services may be found in the attached *Steps You Can Take to Help Protect Personal Information*.

**What You Can Do.** We encourage you to remain vigilant against incidents of identity theft and fraud by reviewing your account statements. Additional information may be found in the attached *Steps You Can Take to Help Protect Personal Information*.

### **TAKE ADVANTAGE OF YOUR IDENTITY MONITORING SERVICES**

You have been provided with access to the following services from Kroll:

#### **Single Bureau Credit Monitoring**

You will receive alerts when there are changes to your credit data—for instance, when a new line of credit is applied for in your name. If you do not recognize the activity, you'll have the option to call a Kroll fraud specialist, who will be able to help you determine if it is an indicator of identity theft.

#### **Fraud Consultation**

You have unlimited access to consultation with a Kroll fraud specialist. Support includes showing you the most effective ways to protect your identity, explaining your rights and protections under the law, assistance with fraud alerts, and interpreting how personal information is accessed and used, including investigating suspicious activity that could be tied to an identity theft event.

#### **Identity Theft Restoration**

If you become a victim of identity theft, an experienced Kroll licensed investigator will work on your behalf to resolve related issues. You will have access to a dedicated investigator who understands your issues and can do most of the work for you. Your investigator will be able to dig deep to uncover the scope of the identity theft, and then work to resolve it.

Kroll's activation website is only compatible with the current version or one version earlier of Chrome, Firefox, Safari and Edge.

To receive credit services, you must be over the age of 18 and have established credit in the U.S., have a Social Security number in your name, and have a U.S. residential address associated with your credit file.

### **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order your free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. You may also directly contact the three major credit reporting bureaus listed below to request a free copy of your credit report.

Consumers have the right to place an initial or extended "fraud alert" on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer's credit file. Upon seeing a fraud alert display on a consumer's credit file, a business is required to take steps to verify the consumer's identity before extending new credit. If you are a victim of identity theft, you are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should you wish to place a fraud alert, please contact any one of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a "credit freeze" on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer's express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in your name without your consent. However, you should be aware that using a credit freeze to take control over who gets access to the personal and financial information in your credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application you make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, you cannot be charged to place or lift a credit freeze on your credit report. To request a security freeze, you will need to provide the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver's license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if you are a victim of identity theft.
