On or about February 23, 2023, during a review of court files, it came to the attention of AGO staff that certain case pleadings filed by the AGO with the Superior Court Clerk's office contained your personal information in unredacted form. Specifically, your date of birth, social security number, and credit card number were part of a court filing that the AGO filed with the Superior Court on or about 10/30/2019 in the matter of *Commonwealth of Massachusetts vs. Safe Home Security Inc.*, Case No. 1984CV03403 (Suffolk Sup. Ct.).

We have determined that this incident was not the result of any system failure, compromise, or attempts by external actors to steal data, but solely due to human error. Based on our investigation, at no point were the Unredacted Pleadings or the PII (personally-identifiable information) within them displayed on the Superior Court's online docket for the matter (at www.masscourts.org). We also have no evidence that the unredacted PII within the case file was disclosed to or viewed by anyone other than authorized AGO staff, court personnel, and opposing counsel or their client(s). Nor do we have any evidence of unauthorized access to or use of the PII.

While we have no evidence that your information has been misused or further disseminated, we wanted to inform you as soon as possible of what happened and assure you that we are taking steps to ensure this error does not occur again. We have also ensured that the PII is no longer in the court record. Attached to this letter is further information about steps you may want to take to protect your personal information.
