We are writing to inform you of a data security incident that occurred at MCNA Insurance Company ("MCNA") ("we" or "MCNA") that may have involved the decedent's personal information as a provider of dental/orthodontic care to members of Healthplex, Inc., for which MCNA provides certain administrative services.

What happened?

On March 6, 2023, MCNA became aware of potentially unauthorized malicious activity within its network. Upon discovery, MCNA immediately launched a forensic investigation with the assistance of a leading cybersecurity firm to investigate the incident and assist with remediation efforts. MCNA undertook an extensive review to determine what data may have been impacted. As a result of this review, which was completed on May 3, 2023, it appears that the decedent's personal information may have been involved.

What information was involved?

Personal information that may have been involved included: (1) demographic information to identify and contact the decedent, such as full name, date of birth, address, telephone and email; and (2) Social Security number. Not all data elements were involved for all individuals.

What we are doing.

MCNA takes privacy and security very seriously. As soon as we discovered the incident, we promptly launched a forensic investigation, took steps to mitigate and remediate the incident and to help prevent further unauthorized activity, and contacted law enforcement. In response to this incident, we have enhanced our security controls and monitoring practices as appropriate, to minimize the risk of any similar incident in the future.

In addition, we have arranged to offer credit monitoring services through IDX for a period of 2 years, at no cost to you. While these services are complimentary, you have until <<Enrollment Date>> to activate these services. We encourage you to take advantage of this offering, and instructions on how to enroll are included in the enclosed Reference Guide.

What you can do.

In addition to enrolling in complimentary credit monitoring services, the enclosed Reference Guide includes information on general steps you can take to monitor and protect the decedent's personal information. Although we are unaware of any actual or attempted misuse of provider information as a result of this incident, we encourage you to carefully review credit reports and statements sent from providers as well as the decedent's insurance company to ensure that all account activity is valid. Any questionable charges should be promptly reported to the company with which the account is maintained.

<u>Reference Guide</u> <u>Review Your Account Statements</u>

Carefully review statements sent to you from your healthcare providers, insurance company, and financial institutions to ensure that all of your account activity is valid. Report any questionable charges promptly to the provider or company with which you maintain the account.

Provide Any Updated Personal Information to Your Health Care Provider

Your health care provider's office may ask to see a photo ID to verify your identity. Please bring a photo ID with you to every appointment if possible. Your provider's office may also ask you to confirm your date of birth, address, telephone, and other pertinent information so that they can make sure that all of your information is up-to-date. Please be sure and tell your provider's office when there are any changes to your information. Carefully reviewing this information with your provider's office at each visit can help to avoid problems and to address them quickly should there be any discrepancies.

Order Your Free Credit Report

To order your free annual credit report, visit www.annualcreditreport.com, call toll-free at (877) 322-8228, or complete the Annual Credit Report Request Form on the U.S. Federal Trade Commission's ("FTC") website at www.ftc.gov and mail it to Annual Credit Report Request Service, P.O. Box 105281, Atlanta, GA 30348-5281. The three credit bureaus provide free annual credit reports only through the website, toll-free number or request form.

Security Freezes

You have the right to request a credit freeze from a consumer reporting agency, free of charge, so that no new credit can be opened in your name without the use of a PIN number that is issued to you when you initiate a freeze. A security freeze is designed to prevent potential credit grantors from accessing your credit report without your consent. If you place a security freeze, potential creditors and other third parties will not be able to get access to your credit report unless you temporarily lift the freeze. Therefore, using a security freeze may delay your ability to obtain credit.

Unlike a fraud alert, you must separately place a security freeze on your credit file at each credit bureau. To place a security freeze on your credit report you must contact the credit reporting agency by phone, mail, or secure electronic means and provide proper identification of your identity. The following information must be included when requesting a security freeze (note that if you are requesting a credit report for your spouse, this information must be provided for him/her as well): (1) full name, with middle initial and any suffixes; (2) Social Security number; (3) date of birth; (4) current address and any previous addresses for the past five years; and (5) any applicable incident report or complaint with a law enforcement agency or the Registry of Motor Vehicles. The request must also include a copy of a government-issued identification card and a copy of a recent utility bill or bank or insurance statement. It is essential that each copy be legible, display your name and current mailing address, and the date of issue.
