Bank OZK is writing to notify you of a recent data security incident with a file transfer tool used by one of our business partners that might have disclosed some of your personal information. This incident did not involve or affect Bank OZK's network or IT systems.

We have no evidence at this time that your personal information has been used in an unauthorized way, but we are sending this letter to:

- Communicate what happened
- Identify the personal information involved
- Provide details on how to enroll in 24-months of identity monitoring and theft resolution services we are offering to you **at no charge**

## What Are We Doing?

We take this event and the security of information in our care seriously. Upon learning of this vulnerability, our business partner immediately suspended use of the MOVEit Transfer tool, and it remained disabled until our partner received and implemented a software patch to remediate the issue. In addition to launching an immediate investigation, our business partner has taken additional steps to assess the security of its systems and to assist us with notifying potentially affected customers and individuals associated with those customers.

While we are unaware of any identity theft or fraud as a result of this event, as an additional precaution, we are offering a complimentary membership to OnAlert<sup>TM</sup> (Essential Bundle) from ChexSystems®. OnAlert provides you with identity monitoring and can assist with the resolution of identity theft. Details of this offer and instructions on how to activate these services are enclosed with this letter.

#### What Information Was Involved?

The personal information potentially affected varies by individual or business, but may have included your name, Trust and Wealth account number(s), transaction activity, date of birth (DOB) and/or social security number (SSN).

## What Can You Do?

To help protect your personal information, we strongly recommend you do the following:

- Carefully review bank, credit card company, or other financial institutions as well as government institutions like the Internal Revenue Service (IRS) statements. Notify the statement sender immediately by phone and in writing if you detect any suspicious transactions or other activity you do not recognize.
- Enroll in OnAlert, the identity monitoring service that we are offering you. You will receive alerts about any effort to use your name and social security number to establish credit. The service will block that credit from being established if it is not you trying to initiate it.
- Additional steps and resources are available in the accompanying **Reference Guide**. We encourage you to read and follow these steps as well.

When you receive your credit report, review the entire report carefully. Look for any inaccuracies and/or accounts you don't recognize and notify the credit bureaus as soon as possible in the event there are any.

You have rights under the federal Fair Credit Reporting Act ("FCRA"). These include, among others, the right to know what is in your file; to dispute incomplete or inaccurate information; and to have consumer reporting agencies correct or delete inaccurate, incomplete, or unverifiable information. - 1. Your full name (including middle initial as well as Jr., Sr., II, III, etc.),
- 2. Social Security number,
- 3. Date of birth,
- 4. If you have moved in the past five (5) years, provide the addresses where you have lived over the prior five years,
- 5. Proof of current address, such as a current utility bill or telephone bill,
- 6. A legible photocopy of a government issued identification card (state driver's license or ID card, military identification, etc.), and
- 7. If you are a victim of identity theft, include a copy of either the police report, investigative report, or complaint to law enforcement agency concerning identity theft.

Placing a security freeze on your file may delay, interfere with, or prevent timely approval of any requests you make for credit, loans, employment, housing, or other services. For more information regarding credit freezes, please contact the credit reporting agencies directly.

<u>Contact the U.S. Federal Trade Commission:</u> If you detect any incident of identity theft or fraud, promptly report the incident to your local law enforcement authorities, your state Attorney General and the Federal Trade Commission ("FTC").
