Re: Notice of Data Security Incident

We are writing to inform you of a recent data security incident with a file transfer tool used by one of our service providers that compromised some of your personal information while Republic Bank was processing your employer's payroll.

We have no evidence at this time that your personal information has been used in an unauthorized way, but we are sending this letter to:

- Communicate what happened.
- Identify the personal information involved.
- Provide details on how to enroll in 12 months of identity monitoring and theft resolution services we are offering to you at no charge.

#### What Happened?

On May 31, 2023, Progress Software reported a previously unknown vulnerability in its MOVEit Transfer tool. Thousands of companies, including one of our service providers, use this file transfer tool to move data files. Upon notification, our service provider immediately suspended the use of the MOVEit Transfer tool, and it remained disabled until our provider received and implemented a software patch to remediate the issue. Our service provider also launched an immediate investigation, working alongside cyber experts and appropriate law enforcement agencies. The investigation revealed evidence that an unauthorized third party accessed certain files transferred through MOVEit Transfer that contained some of your personal information. We possessed this information because Republic Bank is used by your employer for processing your pay.

There is no evidence at this time that your personal information has been used in an unauthorized way.

#### What Information Was Involved?

The personal information consisted of your name, the bank routing number, and financial account number of the account your pay is deposited to, and the dollar amount of one of your paychecks.

#### What We Are Doing.

Once our service provider notified us of the incident, we immediately worked with our vendor to ensure that they had resolved the vulnerability to keep our customer information safe following the incident and moving forward. We can confirm that, upon learning of the incident, the vendor took steps to secure their environment and further validated that security using a third-party forensics firm. We also began an investigation, worked with our provider to determine the scope of the incident, and notified our impacted customers.

Box 105281, Atlanta, GA 30348-5281. Do not contact the three credit bureaus individually; they provide your free report only through the website or toll-free number.

When you receive your credit report, review the entire report carefully. Look for any inaccuracies and/or accounts you don't recognize, and notify the credit bureaus as soon as possible in the event there are any.

- 5. Proof of current address, such as a current utility bill or telephone bill
- 6. A legible photocopy of a government issued identification card (state driver's license or ID card, military identification, etc.)
- 7. If you are a victim of identity theft, include a copy of either the police report, investigative report, or complaint to law enforcement agency concerning identity theft

Placing a security freeze on your file may delay, interfere with, or prevent timely approval of any requests you make for credit, loans, employment, housing or other services. For more information regarding credit freezes, please contact the credit reporting agencies directly.
