DECISION

YANKEE SPIRITS INC. D/B/A YANKEE SPIRITS 628 WASHINGTON STREET ATTLEBORO, MA 02703

LICENSE#: 00047-PK-0050

VIOLATION DATE: Various in October 2023

Yankee Spirits Inc. d/b/a Yankee Spirits ("Licensee" or "Yankee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a remote hearing via Microsoft Teams on Tuesday, June 11, 2024, regarding alleged violation of 204 CMR 2.04 (1) No holder of a license issued under M.G.L. c. 138, § 15 shall sell or offer to sell any alcoholic beverages at a price less than invoiced cost. Cost is defined as net cost appearing on the invoice for said alcoholic beverages. Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Special Investigator Gardner's Report.

FINDINGS OF FACT

- 1. The ABCC Investigative and Enforcement Division received a complaint that the Licensee was selling Josh Pinot Grigio wine below invoiced cost.
- 2. On Thursday, November 9, 2023, Investigators Terasconi and Gardner ("Investigators") addressed the allegation with Ray Roy, General Manager, who explained that Yankee holds a *Yellow Dot Sale* each October wherein the Licensee offers a 20% discount on wines marked with a yellow dot.

- 3. Mr. Roy referred Investigators to Elizabeth LaClair to further address the specific allegations and for invoices and pricing information.
- 4. Ms. LaClair provided Investigators with invoices from Ruby Wines which listed the cost of one 750 ml bottle of Josh Pinot Grigio as \$11.67.
- 5. A review of sales records provided by Yankee indicated that the regular retail price of Josh Pinot Grigio is \$12.99, and the *Yellow Dot Sale* price is \$10.39.
- 6. Ms. LaClair confirmed that Yankee's documentation indicated sales made below cost occurred on 11 occasions in October 2023.
- 7. James Juliano, Officer of the Licensee entity and Megan Jones, stockholder and director of the Licensee entity appeared at the Commission hearing, along with Mr. Roy and Ms. LaClair. The Commission was informed this was product was added to the *Yellow Dot Sale* as a result of human error, and all other items included in the sale were offered and/or sold in compliance with the law.
- 8. The Licensee has held a license under M.G.L. c. 138, § 15 since 1995, nearly 30 years, with no prior violations.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.04 (1) No holder of a license issued under M.G.L. c. 138, § 15 shall sell or offer to sell any alcoholic beverages at a price less than invoiced cost. Cost is defined as net cost appearing on the invoice for said alcoholic beverages. Therefore, the Commission issues a **WARNING**.
