DECISION

VRPATEL LLC D/B/A MASS DISCOUNT LIQUORS 844 SOUTHBRIDGE STREET AUBURN, MA 01501

VRPatel LLC d/b/a Mass Discount Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, July 22, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators David and Temple's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators David and Temple's Minimum Purchase Age Compliance Check Field Report, 5/13/25;
- 2. ABCC Licensing Authority Certification, Transfer of License Approved, 11/21/2024;
- 3. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

FINDINGS OF FACT

- 1. On Tuesday, May 13, 2025, at approximately 8:17 p.m., Investigators David and Temple ("Investigators") conducted a compliance check at VRPatel LLC d/b/a Mass Discount Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 24 ounce Modelo beer for four dollars and fifty cents (\$4.50). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2024.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING**.
