Honorable Chairs and Ranking Minority Members of the Committees on Ways and Means:

Pursuant to Section 6 of Chapter 14 of the General Laws¹, the Department of Revenue (DOR) hereby submits its mid-month tax revenue report for the month of August 2019, the second month of fiscal year 2020. The attached table shows August 2019 month-to-date tax revenue collections through August 15, 2019, along with changes from the equivalent period in August 2018.

Revenue collections are uneven and weighted toward month-end, and the brief period covered in the mid-month does not provide sufficient data for comparison to prior years. Therefore, the Department urges that mid-month figures should not be used to assess trends or project future revenues.

Context for August revenues

August is one of the smaller months for revenue collection, because neither individual nor business taxpayers make significant estimated payments during the month. On average for the past several years, roughly 6.7% of annual revenue has been received during August.

Highlights

- **Total Tax** collections for the month-to-date period were \$814 million, up \$49 million or 6.4% versus the same period in August 2018.
- **Income Taxes** totaled \$601 million, up \$44 million or 8.0% versus the same period in August 2018.
- Sales & Use Tax collections were \$113 million, up \$4 million or 3.2% versus the same period in August 2018.
- **Corporate & Business Taxes** were \$25 million, up \$12 million or 94.2% versus the same period in August 2018.
- Other Taxes totaled \$76 million, down \$11 million or 12.3% versus the same period in August 2018.

Detail

Total Income Tax of \$601 million for mid-month August comprises the following:

- Withholding of \$578 million, up \$33 million from mid-month August 2018.
- Estimated Payments of \$14 million, up \$3 million from mid-month August 2018.
- **Returns/Bills** of \$16 million, up \$1 million from mid-month August 2018.
- **Refunds** of \$8 million, down \$7 million from mid-month August 2018. Because refunds are an outflow, this represents a positive variance from the prior year.

Sales & Use Tax collections of \$113 million for the August month-to-date period are \$4 million or 3.2% more than the equivalent period last year. Only a small proportion of expected Regular Sales and Meals tax remittances, subcategories of Sales & Use Tax, are received by the mid-month date; the bulk of these payments are expected on or after the 20^{th} of the month.

- \$56 million in Regular Sales Tax collections, up \$5 million from mid-month August 2018.
- \$18 million in Meals Tax revenues, up \$1 million from mid-month August 2018.
- \$39 million in Motor Vehicle Sales Tax revenues, down \$3 million from mid-month August 2018.

Corporate & Business tax revenues were \$25 million, up \$12 million from mid-month August 2018.

All Other includes a number of tax categories including motor fuels, cigarettes, estate taxes, and deeds. All other revenues totaled \$76 million, which is \$11 million less than the mid-month August 2018 figure.

Because collections are weighted to the end of the month, we do not use the mid-month figures to project full-month revenue. Comparisons to prior-year periods are unreliable because of normal fluctuations and calendar differences in the short 15-day window of incremental data.
